Brenda opened the meeting at 7pm.

1. Brenda said that Wedmore and Minehead have asked to join the Ladies Afternoon League. The distance in travelling to Wedmore was discussed. Brenda and Gill will attend the AGM where this will be discussed.

2. Angie has suggested keeping the same team for cup matches when they are doing well. This was felt to be difficult sometimes depending on availability.

3. Playing matches in 'inclement weather'. Some matches have been started when the weather is not really suitable for bowling. It was felt that this is a safety issue and that clubs could be liable if something happens. Some members stated that they would not play if they did not feel it was safe. It was felt that SBA should look into the rules and state what constitutes 'Inclement weather.'

4. Ann thanked people for taking part in the Saturday League and asked if they were happy with her and Lynda doing the organisation. Gill thought that all leagues should come under the one umbrella but Brenda did not want to run this, and it was felt that things were working well how they are with Brenda being informed if necessary. Ann said that South Petherton have asked to join this league.

5. Janet Moore suggested there should be a Ladies practice session for rinks as some leagues are still in this format. This was thought a good idea if this could be arranged.

6. Ladies friendlies were discussed, and it was said that it is difficult due to other clubs pulling out with not being able to get a team. There are a good number of mixed friendlies.

7. Ann thanked everyone for doing the food for the Saturday league and Wyn for covering other matches. Win was presented with flowers for all her hard work with the teas.

8. At the moment no one has volunteered to take on the job of catering manager. Numerous people are willing to help but someone is needed to take overall responsibility. This does not have to be a lady.

The indoor rink continues to generate complaints from members. It is clear that the recent relaying of the underlay has failed. Parts of the carpet have lifted and the seams are so prominent that bowls jump traveling over them. Many of our indoor members play at other local indoor clubs; they will recognise how poor our indoor rink is. The invoice for the relay arrived with Phil a few days ago, it is ~£1500.00 Phil has not paid for it yet. In my opinion the Executive should consider withholding some or all of this fee until the indoor rink is in a satisfactory condition. If a deduction is to be made Phil asks that a member of the Executive contacts Greengauge to explain the decision. Direction is required on this issue.

By the time of the meeting the draw will have taken place for the men's singles and mixed pairs competition, with the finals the weekend before Christmas.

Everyone who came on the Tour enjoyed themselves overall we won a few rinks but not any full games but we had fun trying, although I think everyone was trying to get lowest score to see which Rubber Duck they could pick, I have

temporary booked next year so far no one has booked, I have to collect £25 pp for March at the moment as we have to pay this ASAP.

Closing of the green went well again everyone enjoyed the day in case you did not realise we raised over the year £1022.30 for guide dogs, this was Ann's charity.

I must apologies I cannot make Thursdays Meeting due to another hospital appointment. I will say however if you are voting about indoor carpet payment I would suggest **NOT** pay, if we do pay, will we have a job getting them back, We held the Friends of the Park AGM on Saturday; the Ladies produced another fine buffet for them. We spent £133.00 on the food and charged them £7pp = £280 so the club made around £150 plus bar takings.

This will be the last Buffet that the Girls will be doing.

10 Greenkeeper's Report

The winter dressing of the Green was completed on Sat 28 by the green team ably assisted by Robin Shaw, Philip Hutchings, and Will Smith. Thank you to all that helped it was an eye opener to the work that takes place for those not having participated before. The weather was challenging in that week but having delayed the work, it was perfect on the day and a good finish was achieved.

Ten days before the season finished a hole was dug in the middle of the green 100mm square and 75mm deep, what dug that hole and subsequently is reopening it after filling on regular occasions remain a mystery despite having put up a camera to capture and confirm what is causing the damage. I did see small paw prints in the top dressing surrounding the hole suggesting it is a fox but having blocked access under the gates it is still occurring unless of course it is resident under the sheds, and I have trapped it in! The hedge was removed as agreed quotation this week the rubbish and debris is significant. It will require a work party to get the surface to an acceptable finish for landscaping it appears historically rather than removing rubbish it has been discarded under the hedge.

A new gated entrance is a priority as the main supports on one side have failed, and the abutting fence panel is not secure.

We removed the Green edging on the indoor rink side of the green as the wooden marker rails had rotted. They need replacing I am looking at making the top rail a recycled plastic product to stop water ingress to the drilled holes for markers. The last top rail replacement have failed within 6 years of being put up, the cost indicate that the plastic is three times the price of timber but guaranteed to last 25 years. Will discuss at Exec. The astro turf is also life expired as full of moss. A replacement fertiliser spreader is required as the existing one failed due to the metal frame rotting with rust. A suitable replacement is £189.00 inc Vat purchasing from the best priced supplier for a CobraHS26S. That has a stainless-steel frame that should increase the working life from coated steel options.
