025.13 **Apologies** – to agree any absences of councillors.

Apologies were received from Nigel Challis (away) and Cllr Diane Andrews (NFDC) as she was attending Copythorne' Parish Council's meeting.

026.13 **Declarations of interest.**

027.13. **Minutes** – It was agreed that the minutes of 26 February 2013 were a true record – these were duly signed

028.13 **Matters arising** from the minutes of 26th February 2013 – no matters arising.

029.13 **Reports to be received**

i) County Cllr Edward Heron

Edward advised of a new scheme about to be launched by Hampshire County Council for minor highway schemes up to 10K in value – Applications/interest needs to be registered by 1 June 2013.

He also asked that all pot holes are reported as HCC had released extra money to repair the roads.

He also agreed to arrange for the drain 'sucker' machine to look at drains outside Parsonage Farm.

Sue Bennison

Sue requested that article be put in The Bramshaw Telegraph concerning the deaths of 11 dogs that had been walked in Ogdens – cause currently unknown. Clerk reminded the meeting that the Bramshaw Telegraph was meant to be an aide memoire of events happening in Bramshaw rather than a newsletter thus preventing conflict with Forest Views – the conclusion of the discussion was that on this occasion an item should be put into the Bramshaw Telegraph, Forest Views and the website.

Sue brought to everyone's attention the cycle event taking place on 14/15 April and expressed her concern over the size of the event – providing everyone behaves as indicated in the promotional video there should not be an issue – ie:

- i) cycle in single file.
- ii) slow down for horse riders.
- iii) slow down for forest ponies and other forest animals.
- iv) don't drop litter

- v) obey Highway Code – anyone not doing so, will be disqualified.

The NPA is currently holding discussions on such events and their impact on the National Park.

Other items raised by Sue included current situation with the Forestry Commission –

- ie
 - i) there is to be no sell off,
 - ii) there is to be an increase in tree planting
 - iii) it is to receive funding from Europe to create new woodlands
 - iv) will remain in public ownership and responsible to Secretary of State.
 - v) there will greater engagement with local communities.

034.13 **Local transport**

Ian Davies' research into issues around public transport in the parish has resulted in a positive response from Colin Wright (HCC) – he has suggested the tweaking the current taxi share which runs from Fritham on a Tuesday and Friday so that it linked up with other buses either running from Landford (going to Salisbury and Romsey and Southampton) or Cadnam (going to Southampton). Cllr Edward Heron agreed that this should be possible.

The Council discussed what days and routes they believe to be most suitable – conclusion – clerk to write to Colin Wright requesting a trial period of a Taxishare link from Bramshaw Parish to Beech Grange Landford to connect with X7 bus.(in both directions.) To operate twice weekly, say Tues and Thursday. and would allow passengers to access Salisbury and Southampton.
