The Association Membership Secretary and Association officials will maintain a list of full Association membership, whilst local Neighbourhood Watch Scheme Coordinators will maintain a list of their scheme membership. This information may be in the form of either electronic or paper format and is for the purpose of supporting NHW activities and providing information and newsletters.

2. The personal data held consists only of names, postal addresses and contact details, which may include email addresses that have been collected from Member's Registration and Data Consent Forms. Coordinators and scheme members are asked to give consent for inclusion of their details on these listings when registering and signing the Member's Registration and Data Consent Form. Members can withdraw consent at any time by submitting a written / email request to the Association Membership Secretary.

3. The Association will hold personal data for the purposes of supporting NHW activities and providing Association information, crime prevention information and newsletters to its membership via the Association and local Neighbourhood Watch Scheme Coordinators.

4. The database will be updated as and when inaccuracies are notified by local scheme coordinators or members themselves, or identified through routine maintenance of records or through specific contact with members.

5. Coordinators may obtain a copy of their local scheme members' data solely for the purpose of managing and administering their scheme, through submission of a written or email request to the Association Membership Secretary. Scheme members can contact their Coordinator for details of the data held and in which format.

6. Members' contact details will not be shared with other members, or third parties, without the prior consent of the member concerned. This may include sharing such details with West Mercia Police or the National Neighbourhood Watch Network and will solely be for the purpose of providing Members with additional crime prevention information.

7. Members' personal data will not be further processed in a manner that is incompatible with the purposes specified above.
