### 108. Report on Recent Planning Decisions

- F/15/76259 11 Edward Avenue single storey rear extension to existing garage and re-siting of storage building no objection. Permitted
- T/15/76274 62 Underwood Road crown reduce Silver Birch and Cherry Tree and fell one Oak object for lack of a professional opinion and information on the amount of reduction; Councillors were therefore unable to support without more information. Part permitted but Cherry pruning refused as unjustified
- T/15/76260 38 Underwood Road cut back overhanging tree branches object for lack of professional information on impact cutting back will have on the tree. Permitted
- F/15/76384 60 Longmead Avenue (resubmission) two storey side extension and roof alterations including rear dormer to provide second floor accommodation If this resubmission relates to the whole planning application then the Committee's previous comments stand. If this resubmission relates to just the rear dormer then no objection. It is unclear as to what comprises the resubmission and it would be useful to have details included of previous submissions in such cases. Refused as being an unsympathetic alteration to the roof line and visually intrusive
- F/15/76406 1 Scotter Square two storey side extension and external alterations no objection but concern that pre-application advice letter was not included on the website or attached to

documentation provided and concern over additional on road parking by visitors and construction traffic. Permitted

- F/15/76261 38 Underwood Road erect detached double garage and removal of existing no objection. Permitted
- X/156/76408 69 73 Bishopstoke Road variation to C/15/75779 to allow construction of 2.4m high close boarded fence in place of an acoustic fence object on the grounds that the original condition was to protect the character and appearance of the conservation area and for sound mitigation. Refused for insufficient noise mitigation.
