TO ACCEPT APOLOGIES FOR ABSENCE

Apologies for absence had been received from Councillor Jenny Gibson and PC Paul Kemsley.

DECLARATIONS OF INTEREST & REGISTER OF INTEREST CHANGES

There were no declarations of interest on items on the Agenda and no Register of Interest changes.

APPROVAL OF PREVIOUS MINUTES

The Minutes of the Meeting held on 12th March 2009 were **AGREED** and signed as a true record.

LOCAL POLICING

WPCSO Siobhan de Burca began by introducing herself as the new Police Community Officer; she also introduced her Supervisor PCSO Nicola Morris.

Siobhan reported that there had only been 2 reported crimes since the last meeting in May which were:-

May - Tools stolen

June - No crimes

July - Furniture damage

Aug - No crimes

She told the meeting that she would be having a 'Surgery' in Headcorn Library between 4 & 8pm on 8th September and that she would also be setting up one in Grafty Green at some future date. Things like warning people about cold calling could be discussed; any other problems and property marking could be carried out.

The speeding issue was discussed, it was suggested by Siobhan that the first road to go down was for Grafty Green to get involved with Speedwatch which would give Kent Highways more information on speeding motorists giving us more of a case. We are to advertise in the magazine for volunteers to do this at certain times of day, particularly in the morning and evening, the equipment could be borrowed from Headcorn and training would be given by the Police.

MATTERS ARISING from Minutes of 25th March 2009

40-30 Mile Speed Limit Changes

PA reported that Michael Heath at Kent Highways had ordered the blue signs indicating a Police Speed Check Area but like everything else there is a backlog and it could be some time before the signs are installed, he had also agreed to paint 30 signs in the road which he had marked out, but again we are still waiting for that to be done. With regard to an interactive sign this would not be so easy as very few accidents are ever reported and because there have been no fatal crashes we would not be seen as a priority on their system of points. Jenny Whittle suggested that we apply for funding and she would do as much as she could to help us in our quest to reduce the speeding in Grafty Green. She also suggested that it might be a good idea for several Parishes to get together regarding the 'Rat Run' issue. As already discussed in the Police section we are going to see if we have any volunteers who might get involved in Speedwatch. PA reported that she had been in touch with Helen Anderson (Parish Clerk) from Headcorn for any information that she could give as Speedwatch is carried out all the time there.

RG had contacted Kent Wildlife Trust, they would be happy to carry out a preliminary (scoping) survey but it would be necessary for the public to have this done. The neighbours have been made aware.

Robert and Ron had recently attended a meeting at MBC which was all part of the consultation process to put in place their Gypsy & Traveller Development Plan Document (DPD) with the specific purpose of allocating Gypsy and Traveller sites.

Michael Heath has agreed to put up a larger yellow sign warning drivers that the road narrows to a single lane, still awaiting the signs for installation.

It has been discovered that the water leak is not the responsibility of Kent Highways but that of South East Water. PA is to contact them.
