Staff were not told of the closure and were literally taking bookings for rooms and tables on the eve of the closure. Staff believed the rooms were booked to capacity, but food was not to the standard of other local businesses or what the area needed.

The business target wasn't the village which was regularly made clear to the many of the people in the village. The need for a community meeting place is raised.
