21.22.047 POLICE COMMUNITY CHARTER

Constable Jonathan Lightfoot and PCSO Stephen Dunn-Brown explained how the Charter between the Police and the local community would function.

The main points underlying the Charter were as follows:

a) Visibility and Accessibility

Officers with specific responsibility for the area would be based at Bridgnorth Police Station and could be contacted by a number of means, including social media.

b) Responding to the Community

The monthly newsletter would be circulated, giving information to the community and inviting feedback.

The officers confirmed that regular vehicle speed checks were carried out upon the A442, in response to community concern.

c) Prevention of Crime

This would include working with licenced premises, shops and other businesses and giving advice on crime prevention as well as detecting where problems were arising.

d) Engagement

The Police would work with young people, the elderly and vulnerable groups to help them remain safe and avoid becoming involved in or the victims of crime.

e) Relationships

The Police maintained close relationships with local authorities, the Fire and Rescue Service and other groups, including Parish Councils.

The Chairman thanked the officers for their presentation and invited them to attend future meetings of the Parish Council.

21.22.050. LOCAL ROADS AND FOOTPATHS

a) Pedestrian Refuge at Quatt

The Clerk confirmed that he had carried out all the actions agreed at the extraordinary meeting of 1st July 2021 but as yet was awaiting a response from the various bodies with whom he had been in contact.

b) <u>Traffic Calming Measures: Vehicle Activated Signs (VAS)</u>

The Clerk confirmed that he was still seeking a suitably qualified contractor to carry out installation of a new pole to mount the VAS sign at the north end of Quatt Village.

c) The BOAT (Byway Open to All Traffic)

It was noted that the footbridge at the BOAT had been damaged and that the National Trust believed that the Highways Authority were responsible for the footbridge. However, members of the Parish Council recalled that the Trust had installed the bridge originally.

Resolved that the Clerk make further enquiries of the National Trust.

d) Wootton Ford

It was noted that works to repair the footbridge and other works at the Ford had been completed.

<u>Resolved</u> that the Clerk write to thank the team from Shropshire Highways who had carried out the works in a most satisfactory manner.

21.22.051 REPORT OF THE SHROPSHIRE COUNCILLOR

Councillor Elliott Lynch confirmed that new recycling bins for glass, plastic and metal would soon be available to those householders who wished to use them. He also confirmed that he was pursuing the issue of the provision of a pedestrian refuge on the A442 at Quatt with the Highways Authority. Pothole repairs in the area were scheduled to be carried out shortly.

The Chairman thanked Councillor Lynch for his report.

21.22.052. NATIONAL TRUST REPORT

There was no representative from the National Trust at the meeting but the Clerk had been provided with a written report from Marcus Halliwell from the National Trust.

The report confirmed that the tennis courts at the Dower House were not maintained to a standard that rendered them suitable for public use and they were not insured for that purpose.

The Trust would be prepared to grant a licence to any local organization who would be willing to take over responsibility of the tennis courts as a public amenity.

Mr Halliwell's report also confirmed that the Trust might be prepared to support the Parish Council request for a pedestrian refuge in Quatt Village on the grounds that it would facilitate the use of the footpath network in the area.

It was also confirmed that the need for visitors to Dudmaston Hall to book their visit had now been discontinued and it was hoped that a successful summer season would follow.

<u>Resolved</u> that the Parish Council ask Quatt Cricket Club if they would like to take over the tennis courts on the basis outlined by the National Trust.
