Mrs Roscow said that she had reported that RS126 was blocked between Upper and Lower Upnor. All the other paths she had walked were clear. She had attended the Rights of Way Improvement Plan workshop, as had Cllr Etheridge. They had pointed out access problems in the current network within the parish and suggested some aspirational improvements. There was an online survey for all interested parties. There would be a 12 week consultation the following year and the plan was expected to be finalised by the end of 2019. Presentations were also given at the workshop on the Improvement Plan and on the Medway section of the national coastal path.
