WESTON PARISH COUNCIL

Minutes of the electronic Meeting of the Parish Council to be held on Wednesday, October 7th 2020 at 7.30pm

Present: Councillors D. Chase, G. Francis, C. Laughton, P. Laughton. The meeting was also attended by Councillor B. Laughton

The Chair opened the meeting and welcomed those present.

201001 To receive Apologies for Absence and Declarations of Interest Apologies received from Councillors R. Henderson and H Saddington

Open Forum – ten minutes to receive questions and comments from members of the public **No members of the public were present**

201002 To accept the minutes of the meeting held on September 2nd 2020 **Proposer: P. Laughton, Seconder: G. Francis. Accepted unanimously**

201003 To note and report matters arising from the minutes not covered elsewhere on the agenda

- i) Parish Clock update
 - DAC Report had been forwarded to the Councillors, and no further progress had been made. Councillor B. Laughton advised Clerk to contact NottsCC with a view to securing a contribution towards the cost of the clock which he would authorise
- ii) Update about Footbridge Closure over Grassthorpe Beck where Weston FP4 meets Weston FP5
 - No further news. Councillor B. Laughton said he would make enquiries
- iii) Update about the verge at the corner of Colley Lane/Main Street

 The verge and the path had been cleared
- iv) Update about concerns about motorbikes travelling at speed on Great North Road The clerk had written to Heather Sutton and received a reply which was read at the meeting. Not recommended for villagers to undertake any action of their own given the 60 mph limit on the stretch of road outside the village. Letter suggested that the local Beat Officer could carry out an inspection to see whether a mobile speed check could safely be carried out. Councillor P. Laughton agreed to find out who the Beat Officer is.
- V) Update on Rural Broadband Scheme
 Councillor G. Francis reported that there were various schemes available.
 The Rural Broadband Voucher Scheme gives vouchers worth £3.5k for
 Businesses and £1.5k for putting the broadband structure in. Individuals
 register with a provider, who register the area and gauge whether there is
 enough interest. Any Community led group application would need coordinating. Councillor G. Francis has registered a community interest with
 Open Reach. Notts CC has a fund which matches the voucher scheme. An
 alternative is Advanced Fixed Wireless Access (AFWA) Quickline, which
 operates in a similar way to a satellite dish. The infrastructure costs £200£300 per property and has a low internet charge at a decent speed. Notts CC
 have a Broadband Infrastructure Liaison Office. Councillor B. Laughton
 agreed to speak to him to ascertain the position re: Weston.
- vi) Update concerning Defibrillator Box

 The Clerk reported that she had placed a notice in the box asking residents not to put any items in the box, and the box was currently clear.

- 201004 To receive reports from County Council and District Council Representatives

 Councillor B. Laughton reported that the County Council was awaiting the

 Government decision on stricter lockdown rules in the region. He reported that
 the County was low on funds due to the Covid crisis
- 201005 To receive and consider any highways issues:

Councillor Chase reported local flooding that had occurred due to a possible pipe collapse/blockage at the side of the road next to Goosemoor Dyke, and water flooding out of the fields and over the road at the end of Moorhouse Road at junction with Egmanton Road (and has flooded the M1 in the past), rather than into the Dyke. The Clerk is to raise an enquiry/report
