Minutes of the Parish Council Meeting of Kemberton Parish Council held on Wednesday 8<sup>th</sup> July 2025, 7:30PM in Kemberton Village Hall

### 23.25 Chairman's Welcome and Announcements

The Chairman welcomed everyone to the meeting, particularly Giles Greenwood, returning as a Parish Councillor, and Shropshire Councillor Elizabeth Barker, at her first meeting at Kemberton following the May elections.

There were no apologies for absence

## 26.25 Report from Shropshire Councillor

26.25.1 Highways

Cllr Elizabeth Barker reported from a meeting she had attended with Highways on 8<sup>th</sup> July. She noted that one of the issues she had discussed was there not being a Highways Technician in post in the Kemberton area, one is now being recruited. Shropshire Council is underfunded for Highways. Although it might not always seem like it, a good job is being done, there is a lot of demand on the service. There were 100 reports on Fix My Street in the Rural Shifnal division in one week alone.

Cllr Barker asked for Councillors to let her know what roads they wanted prioritising, as she said that she was hoping to shift more priority to Rural Shifnal division.

Cllr Giles Greenwood raised the issue of quality control and asked about who monitored repair work. Cllr Barker requested that she be emailed with any issues so she can follow it up with Highways managers. In response to a question from Cllr Stephen Talbot about spray paint being put around potholes, she said it was done by Highway Technicians and indicated work that had to be done.

Councillors commented that a lack of response from Shropshire Council had been a problem in the past. The problems at Kemberton Junction were noted as a particular example. Cllr James Rennison said that the lack of illumination at the junction had been reported several times but nothing has been done about it to date.

Cllr Barker reported that she had met with the police to discuss anti-social driving, speeding, and driving under the influence. She will be undertaking a speed check with police. She will also be discussing fines.

Cllr Mark Lea raised the Quiet Lanes initiative, noting that it had been raised in the past but not pursued, he commented that roads in the area are well-used by horses, cyclists and walkers. Cllr Barker said she would look into it. Cllr Barker said that she would also look into the possibility of putting a 30mph limit in the village, and any implications of it.

Shropshire Council has sent out a Youth and Community Profiling consultation. The Parish Council covers a small electorate so it was thought it would not be something it would participate in.

The Neighbourhood Fund sum relates to a barn conversion in the Parish in 2022. There is a 5-year timeframe for spending the money on projects. Projects should have a focus on community benefits. There was consideration of re-visiting the idea of putting village gateways at the entrances to the village as a traffic calming measure. It was agreed to bring back prices to the September meeting.

A response to Shropshire Council's survey of Town and Parish Councils was discussed and will be filed by the Parish Clerk.
