Minutes of the Parish Council Meeting held on Tuesday 29<sup>th</sup> October 2019 at 8:00pm in the Vestry, Jacobstowe

### 71. Welcome

Cllr Blakeman, Chairman of the Parish Council welcomed everyone to the meeting.

# 72. Apologies for Absence

Borough Councillor Lois Samuel and Councillor Ulrik Lawson made their apologies prior to the meeting.

## 73. Minutes of the Last Meeting

The minutes of the meeting held on 24th September 2019 were agreed and signed as a true record: proposed by Cllr Hedley, seconded by Cllr Stuart, all in favour.

#### 74. Declarations of Interest

Cllr Hedley for item 79.1 Town Living planning application.

#### 75. Public Speaking Time

75.1 A member of the public said a key had still not been cut for the notice board to enable her to post the Neighbourhood Plan (NP) minutes. Cllr Hedley explained that he was having difficulty finding someone local with a suitable blank to cut it from. Another member of the public offered to get the key cut in Exeter for the Parish Council.

#### 77. Matters Arising

# 77.1 Neighbourhood Plan

Cllr Hedley explained that Locality, the organisation who provide grants in connection with neighbourhood plans, had approved the technical support packages that the NP Group had applied for in respect of site assessments and housing needs. The NP Group had decided not to go ahead with commissioning external consultants to prepare landscape character assessment – some members were not wholly convinced of the value of the study and others baulked at spending so much on a single project, especially without explicit community approval. The drafting of the NP policies is progressing and later this month the NP Group is intending to send out a newsletter to the community updating them on housing, including the outcome of the 'Call for Sites' exercise.

# 77.2 Maintenance of Parish Assets

Cllr Blakeman reported no change, deferred to the next meeting.

### 77.3 Devon Air Ambulance

Cllr Blakeman reported no news, deferred to the next meeting.

### 77.4 Projector

Cllr Hedley reported that a new projector had been purchased and would arrive tomorrow. He will pass on the necessary paperwork to the Clerk. **Action Cllr Hedley** 

#### 77.5 Village Hall Funding

Cllr Stuart explained the kitchen roof in the Village Hall is leaking and the roofing sheets need replacing. He explained the Village Hall committee are looking to see



what funds can be raised through a grant and wondered if the Parish Council should contribute. Cllr Blakeman advised that the Village Hall committee would need to approach the Parish Council direct if they wanted a donation.

77.6 Code of Conduct

Cllr Hedley is still awaiting a reply from West Devon Borough Council, deferred to the next meeting.

77.7 Dog Fouling

After hearing some concerns raised by Cllr Hedley in connection with adopting a 'stick and flick' policy, in particular the likely objection of landowners with grazing animals, Cllr Cobb moved that the Parish Council does not go ahead with the notices, seconded by Cllr Hedley.

The Clerk notified Parish Councillors that a notice had been issued for the purpose of determining whether or not an election would need to take place. The notice expires on 4<sup>th</sup> November 2019 when the Parish Council will be able to co-opt a member if the vacancy is uncontested.
