SPEED WATCH RESULTS ACROSS THE NEW FOREST



<u>Minstead</u>: 51%, were exceeding the 30mph speed limit. Of those, 17 vehicles were travelling at 35mph or more and have received warning letters from the Police. One vehicle was travelling at 48mph in Mill Lane

Lyndhurst: nearly 60%, were travelling over the 30mph limit. 58 of those vehicles have received warning letters from the Police for recording speeds

of 35mph or more with one vehicle on Gosport Lane reaching 47mph. <u>Copythorne</u>: Of the 534 vehicles monitored, 369 were travelling over the 30 mph speed limit with one vehicle reaching a speed in excess of 50 mph.

HM Revenue and Customs Alert

Action Fraud has experienced an increase in the reporting of malicious calls, voicemails, text messages or emails to members of the public purporting to be from HMRC. The fraudsters state that as a result of their non-payment of tax or other duty, the victim is liable to prosecution or other legal proceedings such as repossession of belongings to settle the balance but can avoid this by arranging for payment to be made immediately by method such as bank transfer or by iTunes gift cards.

If the victim is hesitant or refuses to comply, the suspect makes a threat such as immediate arrest, bailiffs or in cases where the victim appears to be of overseas origin; deportation.

What to do

- Always question unsolicited requests for your personal or financial information.
- If something feels wrong, then it is usually right to question it.
- Don't be rushed or pressured into making a decision.
- Report Phishing attempts.

Alert - Fake Tv Licensing Emails

Action Fraud has received more than 5,000 reports about fake emails and texts purporting to be from TV Licensing. The messages contain links to genuine-looking websites that are designed to steal personal and financial information. Always question unsolicited requests for your personal or financial information in case it's a scam. Never automatically click on a link in an unexpected email or text. NF909 – Broomy Lane, Linwood – Passing Places
