  - a. Dial House: Retrospective planning application received. Received by CDC on 10<sup>th</sup> May but not validated by their team for some time which resulted in a delay in it being available on the portal. Propose letter to CDC from Parish Council to express concern about the delay and that Dial House were given the wrong information about their application originally
  - b. Shed at Manor Field: Noted shed has been dismantled but concrete base still in place. Proposed a letter to CDC thanking them for the enforcement and asking them to write to the owner to thank them for the removal of the shed and asking when they will be removing the base.
  - c. Porch at 13 Salmonsbury Cottages: The Clerk had emailed to chase up enforcement on this matter as the breezeblock to the porch extension has still not been rendered.
