DH has also tried to find out the status of the track and who has responsibility with any success. MH to investigate legal advice on what can be done with the track as no one has responsibility for it.

- c) GH has been contacted by Newton Regis Village Hall, regarding a near miss incident during a cricket match. It is suggested that the Village Hall has a warning on their booking form to remind users of the hall to be aware that there is a danger to spectators when a cricket match is in progress. GH to design a warning sign to be erected on the field, carpark and playground.
- d) The application for funding for an all weather cricket strip has been submitted.
