MINUTES OF THE PARISH COUNCIL MEETING (Draft) held at St Peter's Hall, Seaview on Monday 17th June 2019 at 7pm

PRESENT: Cllrs Barraclough (Chairman), Ward, Elliott, Hardie, Gauntlett Gibbs, Colledge, Tuson, Rivlin and Adams

The Chairman welcomed Members and Residents (14)

The Chairman then asked if there were any questions and comments from members of the public. A statement was read out on behalf of the residents of Duver Road regarding the building of a ramp at Sea View Yacht Club's Dinghy Park. It was asked if the Parish Council could write to the Commodore of the yacht club and the IW Council to establish who authorised the work. The Ward Councillor gave a brief explanation as he understood it.

The Clerk was reminded of the need to do some remedial work in Pier Road Dinghy Park for which a quote is to be obtained. The Chairman reminded everyone that the bins will not be moved from Gully Road back down to the area of the new toilets following a site meeting with Island Roads. Signs are to be erected to direct people to their new location.

Clerk's Report:

Page 2:

- Cllr Gibbs has had a meeting at the Primary School and a letter has been written inviting them to form a Junior Parish Council
- £25000 has been deposited into the new Nationwide Savings Account. Any more than that attracts a fee of £20.00 so the Clerk will re-assess and if required, deposit further funds subsequently.
- Most Councillors have now gained access to their new e-mail accounts but any problems need to be reported to the Clerk.
- An e-mail has been received from the Clerk at St Helens about a meeting with IW Councillors but he has yet to receive a response.
- The Clerk has spoken to Ashley Curzon at the IW Council and requested an update on the extension of the footpath at Pondwell. However, nothing yet received.

Page 3:

- The Clerk has ordered a new litter bin for installation at Duver Road through Island Roads. They have also agreed to fit gull proof bin guards in appropriate areas.
- The Chairman and Ward Councillor met with Island Roads to discuss the plans for the bridge at the bottom of Gully Road. See agenda item 19/91.
- The Chairman has e-mailed Martin Hayles asking for a meeting with Redwing Construction over the state of the new toilets. There has been no response so the Clerk will follow up immediately.

Page 6:

- 19/75 A letter was written and submitted to the IW Council and circulated to Parish Councillors on 22/05/2019.
- 19/77 Membership of IWALC has been renewed and the Annual Subscription paid. Cllr Adams now receiving updates and notices of meetings etc.
- 18/78 Consultation letters are to be sent out to householders at Seagrove Bay and responses are requested to the Clerk by 8th July.
- 18/79 The Clerk drafted and sent a letter to OFCOM and copied in Ashley Curzon at the IW Council.
