## **Chairman's Annual Report**

Marden is going through unprecedented times of change and residents' lives are often being changed in ways they never thought would happen 10 years ago. We have a vast amount of development with over 500 new properties being built within a 5-year time span, which will increase the number of dwellings in the village, by c32% by 2020.

The Parish Council's aim is to ensure we are getting the best possible outcome for the village from the developments. We are trying, with varying degrees of success, to hold regular meetings with developers and to ensure they understand residents' concerns be that highways, flooding, noise, hours of working, mud on the road and anything else that arises. Of

note has been the area at the back of the Playing Field where there has been a problem with fly tipping and rubbish and we were very grateful to Millwood for agreeing to clear the Parish owned land as well as their own. Although it is very disappointing that the area is again in a disgusting state and as bad as it was before the clearance took place. The developers at the solar farm in Plain Road have supplied and fitted, free of charge, solar panels at the Memorial Hall. Redrow agreed to reinstate the off road parking for residents of Spring Grove Cottages, after we met with them, having applied to have it removed from the plan. We hope there will be further good news stories in the months to come.

Section 106 monies have been allocated to the Playing Field from both the Highwood Green development and the Parsonage. Our first priority has been to replace the outdated and scruffy children's play equipment in the Napoleon Drive Play Area, now that we own it, with equipment suitable for the under 5's. Following a public consultation a contract has been placed with Wicksteed, a major supplier of play equipment, and work is due to start in June. We have plans to install an adult gym, a much improved youth shelter and a new sports wall. We are also looking at the possibility of installing a walking/running track round the perimeter of the playing field and improving, enlarging or replacing the changing rooms so that they can become a more inclusive village facility.

Parking and road safety is a very major concern to residents, not least outside the School. We have worked with Kent Highways and the Planning Department at Maidstone Borough Council to push the case for a controlled crossing, which has been specified as a planning condition on three of the major developments. We understand that one of the developers will be installing a puffin crossing, but as yet we do not know when that will be.

The Parish Council sent out a parking survey last summer to residents and the results have shown us that there's no easy solution. Undoubtedly the improved train service to London has made Marden more attractive to commuters from outside the village and we will be pushing the case with Southeastern to increase the car parking capacity at Marden Station, but finding the right person to speak to, and who can make a difference, is a challenge.

It was very gratifying that around 60 adults and many children took part in our annual litter pick on 18 March. Whilst it is very disappointing that we have to do this to keep our village and surrounding countryside looking beautiful, there's always a great deal of community spirit on the day and I know that those residents who participated gained a great deal of satisfaction from it. If more people are willing to take part next year then we can have an even greater impact.

I would like to thank all my colleagues on the Parish Council who voluntarily put in a great deal of time and effort on your behalf. What you see at meetings is only a tiny proportion of what they are doing behind the scenes. I particularly want to thank our very hard working Clerk, Ali and Assistant Clerk, Erika. They often work above and beyond their contracted hours, deal with a huge variety of issues, have exceptional knowledge of all things Marden and remain cheerful, welcoming and unflappable. We are truly lucky to have the services of two such exceptional people here in Marden.

### **Summary Amenities Report**

Marden Parish Council always strive to improve amenity facilities which are such an important village asset and the Amenities Committee is responsible for the open space in the village owned by the Parish Council along with the Cemetery, Rookery Path and Public Toilets. We also organise the annual village Christmas celebrations, the Summer Play Scheme and other ad hoc Events.

Marden Playing Field Our main priority is to maintain this vital area of village open space to a high standard. Our village caretaker, Colin Judge, undertakes the maintenance, including the mowing and landscape management. Monthly tree inspections are carried out at both the Playing Field and Rookery Path (along with Southons Field and the Cemetery) to ensure they are safe and remedial work undertaken if necessary. We also maintain the changing rooms, which are owned by the Parish Council and used by Marden Minors Football Club.

Of upmost importance is the maintenance of the play equipment and regular safety checks are carried out and corrective measures taken where necessary. CCTV has now been installed to monitor any anti-social behaviour in the playing field, which our PCSO Nicola Morris and Parish Clerk continue to monitor.

As ever the problem with dog mess continues, and whilst the field is covered by Maidstone Borough Council Dog Control Orders, they do not clear up the mess in the field. They will respond if dog owners are reported of allowing their dogs to foul the field and they will then visit to monitor and view. Our Community Warden Mira Martin monitors the situation and it is such a shame that a few irresponsible dog owners spoil things for others.

Southons Field The Parish is very fortunate to have an additional open space at Southons Field with its numerous species of trees and both the 'Kent Men of Trees' and the Hadlow Tree Warden were very impressed on their village walkabouts last year. Usage of the field has certainly increased particularly by families as a peaceful and safe haven to run around, have a picnic on the benches, or play on the Play Trail For these reasons the field is kept 'dog free' (apart from guide dogs).

Marden Cemetery Again the Parish is lucky to have such an attractive and well maintained Cemetery with a convenient footpath running to it from the village centre. I would like to record our thanks to Ian Jones, our groundsman, for all his effort and hard work he puts into maintaining it to a very high standard. I am sure you will all agree it is a delightful, peaceful and important facility.

We have already started to form a new area, which will come into use over the next few years. A central flowerbed has

been created and gradually being planted up, and we will be starting the layout of this area shortly lining the new pathways with shrubs etc.

Public Toilets We recognise that the Public Toilets are an important public facility, which the Parish Council has responsibility for although Maidstone Borough Council owns them. Thankfully, there have only been a few anti-social behaviour incidents there recently. A cleaner services them daily and lan regularly checks and locks them daily, and Colin has been dealing with any maintenance that is required.

## **Summary Planning Report**

The Planning Committee has been kept busy with close to 100 residential applications during the past year. It is often not realised that the Parish Council can only make recommendations to Maidstone Borough Council (MBC), but the Planning Committee has a mix of experience that is much respected by the decision makers at MBC.

The Highwood Green development by Redrow has now been completed and has integrated into the Parish in a seamless manner, and the Council is endeavouring to ensure that the remaining housing developments are equally as sensitive to the needs of our village. Industrial developments such as the new Solar Farm off Plain Road, has needed careful oversight and the committee is most diligent in reviewing traffic plans. Within the larger housing development plans are commitments to provide village facilities under the S106 scheme, and the Parish Council is assiduous in ensuring the developer's commitments are neither overlooked nor forgotten. The Pedestrian crossing located near to the school rate as extremely important in this context.

The compound effect of the new housing developments on the village parking and traffic flow is a constant concern and the Parish Council is taking a holistic approach to the problem, and has taken full note of the views expressed by parishioners in the recent parking survey. Many of these views reflect directly on planning applications.

The Marden Neighbourhood Plan (MNP) and the MBC Draft Local Plan are all progressing well and will be welcome tools for the committee in exercising the planning responsibilities.

Finally, many parishioners keep themselves abreast of Parish Council matters by reading the agendas/minutes on the various notice boards scattered around the village, but remember you are welcome to attend any planning committee meeting and many thanks to Erika for clerking at the Planning Committee.

## **Village Caretaker Opportunity**

Marden Parish Council is looking to appoint an employed Village Caretaker working, on average, 15 hours per week (days of working to be agreed between successful candidate and the Parish Council. The hourly rate will be £9.00 – with a review following a six month probation plus holiday pay and the provision of a Pension Scheme.

Tasks include:

- Mowing, strimming and site maintenance of Parish Owned land and other areas as directed
- General maintenance jobs around the parish (ie painting, repairs, grounds maintenance)
- Regular inspections and general maintenance of play equipment, public conveniences and changing rooms
- General litter picking
- Winter maintenance to include snow clearance and distribution of salt where applicable
- Assist with quarterly newsletter distribution and installation and maintenance of Christmas lighting as required
- To work alongside Cemetery caretaker when required
- Key holder for Parish owned properties and gates
- Liaise with other staff, members of the public and contractors
- Any other tasks as directed by the Clerk and Assistant Clerk of the Parish Council

Relevant equipment will be provided and training given where required.

The successful applicant should be fit and healthy for the demands of the job as some aspects involve manual handling. Desirable skills include a knowledge of carpentry, grounds maintenance, tree work and machinery. A DBS check will be undertaken

The successful applicant should be able to work on their own, live locally and have a clean driving licence (a Parish vehicle will be provided).

# Grand Opening of the Napoleon Drive Under 5 Play Area

As Kate has already mentioned, the new under-5 play

equipment will be installed by the end of June. We would like to invite parents, grandparents and children to come along to the 'Grand Opening' on 18th July 2017 at 6.30pm — our Chairman Kate Tippen will cut the ribbon!

### **Marden Business Forum (MBF)**

The MBF is 10 years old this year and has approximately 100 members representing both large and small businesses. Their challenge this year is to capture more of the 200 companies operating in Marden so everyone can benefit from learning and sharing with each other. The MBF proudly promotes Marden as a great place to do business and is a local platform to enable businesses to come together in the community. The yearly Marden Business Showcase shows the community what local businesses produce and offer which is wide ranging and includes the production of local wines, ciders and gin, manufacturing of equipment and products, plant nurseries, health and fitness to name but a few. ### What is a puffin crossing?

The zebra crossing outside the School is due to be upgraded to a puffin crossing, although we don't yet know when. Residents have asked what a puffin crossing is – this is what we've found out.

Pelican and puffin crossings are essentially the same, both are controlled by traffic lights. The lights on a pelican crossing will turn red when a pedestrian presses the button and will stay red for a set period of time, before flashing amber and then turning green, regardless of whether or not there are still pedestrians on the crossing. A puffin crossing has its sequences controlled by sensors mounted on lights, rather than a timer. These sensors can detect whether any pedestrians are on the crossing and control the colour of the lights accordingly. Once the control button has been pressed the lights will only change back to green when the crossing is clear. Puffin crossings do not have a flashing amber phase, motorists have to wait until the lights turn green before they move off.

## **Railway Consultation**

Marden Parish Council (MPC), on behalf of the Parish, meet regularly with both South Eastern and Network Rail, and also attend South Eastern consultation events and Kent County Council Rail Summits. The Department for Transport has launched a consultation on the next South Eastern franchise and there is a possibility that, in the future, some trains may reduce calling at certain stations on the line between Ashford and Tonbridge.

Marden Parish Councillors discussed this consultation at the May Full Council Meeting and their response has now gone back to DfT. Although Parish Councillors responded on all questions on the consultation they strongly opposed the proposal of reducing journey times by reducing stops at less well used intermediate stations and reducing the choice of central London destinations (ie Charing Cross and Cannon Street). ### Planned Roadworks

It is not easy to always report roadworks/closures but when we are notified Ali or Erika try to put something on the Parish Council website and Facebook (we are looking to start Twitter but no date for this has been agreed yet). However when we can we will add a piece in the Newsletter and this edition we have been told about several schemes in time to include: Gas Works – Laurel Villas to Spring Grove Cottages, Goudhurst Road (now to 14th June)

Kent Highways Micro Surfacing – Pattenden Lane to Westfield, Goudhurst Road (9th to 12th July)

BT Outreach – opposite The Limes, Church Hill (15th to 19th June)

BT Outreach – Village Club to The Copse / opposite South View, Howland Road (15th to 19th June)

There are no plans for road closures for any of the above but please expect delays.

Neighbourhood Watch is all about communication and being that extra pair of 'eyes and ears' to assist the police which can help keep communities safe and reduce crime. They would be particularly interested in hearing from residents who may have recently moved onto new housing developments in the Marden area. The number to dial is 0800 555111. Crime statistics are based on people reporting issues and hopefully soon we will be able to report incidents online.

### A New Home for Marden Post Office

We'd like to wish Will & Jill Welby a happy retirement from the Marden Post Office and thank them for all their hard work over the past years. As you know, after nearly 120 years, the Post Office has now moved next door to Crowhurst & Tompsett, the Village Store.

The move means that Marden Post Office has had just three homes since it was first opened in the 1880s. The original location was in the High Street and is now a private house. Until the 1990s it had been, for many years, a tobacconists and sweet shop with various owners that older residents may remember such as Doveys, Mudies, Ollies, and Vicky Clark.

When my grandfather, F.W. Tippen, took over as Postmaster he soon realised that this shop was too small and moved into what we have all known as the Post Office at the turn of the 20th Century. The business also included watch-making and the sales and repair of cycles and motor-cycles. This required further expansion and the glass-fronted first floor extension in 1903. When he died in 1926, the Post Office element was taken over by his children, notably his daughter Alice. She left the village in the 1950s when the business was taken over by Frank & Jesse Wood before, in turn, being run by John & Vera Pert and in recent times by Will Welby. Just four owners in nearly 140 years is not a bad record of dedication and consistency. We wish Nav Athwal and his team all the best for the future running of Marden Post Office in its new home. The future of the Old Post Office is uncertain at the moment - 'watch this space'!

#### **Low-cost Alternative to Sandbags**

#### **Beware – Asian Hornets**

Please be aware of the unfortunate arrival of the Asian Hornet keep your eyes open and let the relevant authorities know if you think you've spotted one. Last September an Asian Hornet's nest was discovered in Gloucestershire and although it was destroyed, it is highly possible that mated queens had already left the nest and could have hibernated over the past winter. If that has happened, then the Asian Hornet will soon spread throughout the rest of the country. Unfortunately, our diminishing and threatened honey bees have no defence against this non-native species, and in less than a day, about 30 Asian Hornets can kill a colony of bees. It's vital that sightings be reported to the appropriate authority so their nests can be located and destroyed.
