

The entire route is approximately 5.5km in length and so far we have installed approximately 3.5km. We will soon begin to start work at the A47 slip road and fly over which will then lead on to the installation of the main along New Sporle Road. The work under the A47 slip road and crossing will commence on **05th August 2019** and some traffic management measures (traffic lights) will be in place during these works. The work will then move onto New Sporle Road on the **12th August 2019** when a road closure will come into effect. We will be installing a new pipe along New Sporle Road and constructing a new manhole in the road.
