C/23/001 **Apologies**
Cllrs Lawrence and Boney sent their apologies.

C/23/002 **To receive declarations of pecuniary interests (DPIs) and other significant interests from members concerning items on the agenda**
Cllr Foord declared an interest in planning item 23/00940.

C/23/003 **Public Participation**
The member of the public updated the Council on the handover of Test Valley School to the HISP Academy Trust. He explained that the existing Board of Governors was due to step down as part of the process of Academisation. He said the school continued to strengthen the leadership team and to respond positively to the difficult OFSTED report (C/22/180). He had been talking to Cllr Powell about developing links between the Football Club and TVS.

C/23/004 **Minutes of the Council Meeting held on Thursday 16th March 2023**

C/23/006 **Town Hall Bookings**

C/23/007 **Stopwatch Crime Prevention What's App group for traders**

The Clerk had been contacted by Sgt Boughay, the boss of the Stockbridge's community PCSO to say that the Police view was that the crime level in Stockbridge did not warrant the involvement of a PCSO on the What's App group. Cllr Jackson said she felt that setting up a group that encompassed all the businesses (including pubs) in Stockbridge held merit. Cllr Foord agreed to approach the SBA to widen their security What's App group to all traders on the High Street.
