## 49/18 5 year plan and Capital Expenditure

The Clerk had updated the 5 year plan in accordance with the end of year forecast as discussed at the January meeting for the revenue accounts and had finalised the capital accounts as statements had been received for these.

After discussion it was agreed that the revenue figures would not be amended until the end of year accounts had been completed.

The monies held in the two Capital accounts (Santander and NS&I) had been ringfenced several years ago and ClIrs agreed that these should be revisited to agree future projects and expenditure.

Several suggestions including short term projects, open space improvements/purchases, public art, fencing at Marden station. Cllrs were asked to give these some thought and to view the S106 Developer Contribution document for further ideas.

The Clerk provided a brief history of the capital funds along with what had been spent in previous years to give Cllrs an idea of what had been purchased in the past. A further meeting would be held early in the new financial year to discuss further.

## 52/18 Council Policies


