### **Clerk Report**

### **Section 137 Expenditure Limit 2024/25**

The Department for Levelling Up, Housing and Communities (DLUHC) confirmed last week that the amount that parish and town councils can spend under **Section 137 for 2024/25 is £10.81 per elector**. This figure is calculated by increasing the amount of £9.93 for 2023/24 by the percentage increase in the retail index between September 2022 and September 2023, in accordance with Schedule 12B to the Local Government Act 1972. Section 137 is the power to incur expenditure for certain purposes not otherwise authorised.

EE Ltd - From 31 March 2024, the phone tariff will increase by £0.47 a month. This increase is linked to inflation in line with the terms and conditions.
