7. <u>Matters arising from previous Minutes</u>

a. Village Hall Emergency Items Storage and Sand Box – Update on Grant.

b. Footpaths – Cllr Main to feedback on conversation with Martin Fry on WCC funding for stile replacement.

d. Ditches feedback from David Tiley – Update.

e. Land Registration – Clerk to update.

The clerk informed the meeting the land outside the hall and the village green had been advertised in the Leamington Courier on 5th January 2000, and the Council would have to wait 12 years before completing registration documents. The clerk had also prepared a poster with respect to the Councils intention to be placed permanently on the notice board. Cllr Bolton informed the meeting that the Council had received information that confirmed the verge in front of Ashorne House is owned by WCC Highways. *Clerk to put poster on notice board*.

District Cllr Wright reported the following:

Concerns with the new recycling arrangements, and that SDC would have to communicate well to residents over the coming months.

Recent District Council elections had resulted in the Conservatives loosing 5 seats, and there were two recounts in the Wellesbourne ward resulting in the election of Cllr S Main with a majority of 5.

The planning area was going to change and Newbold Pacey and Ashorne would come under Kineton and Southam.

Attempts to integrate some District services with County Council to improve services and save costs were not going well as WCC want a veto.

Recently the police were called into account for their 12.8% precept rise and they explained they were the smallest County force and required the increase to maintain services. They may have to respond to Government pressure and reduce next year's precept.

There was no Police presence at the meeting. It was agreed that the Clerk should write to Inspector Deveroux to request support at least once a year.
