7 TO RECEIVE REPORTS from County, District and Town Councillors and Community Groups Representatives.

Cllr Lukaniuk reported the A1065 has been closed all day due to a water leak with railway crossing barriers also closed. S106 money received from local developments is being chased for the provision of cycle ways in Brandon. Cllr Lukaniuk also reported that the rubbish collection at the Forestry Commission St Helen's Picnic Site had to be expedited due to the amount of rubbish that has accumulated recently. Cllr Lukaniuk is in conversation with the Forestry Commission regarding this matter.

Cllr Palmer reported that he has reached agreement with West Suffolk to increase the grass cutting of verges etc to a three week interval.

Cllr Brocklehurst stated they have permission for 19 planters to be sited in the High Street. Funding is currently being sourced. He also queried the establishment of a plant nursery on Council premises re a resolution from last year. Cllr Lukaniuk stated that the establishment of a nursery is dependent on the archaeologists and development of the new cemetery.

Cllr Ridgwell raised the issue to the amount of weeds on paths and roads within the town.

8 TO RECEIVE WRITTEN REPORT from the Town Clerk.

Report was received.

9 PUBLIC FORUM Monthly event limited to 3 minutes duration maximum per resident.

A resident wished to advise the Councillors that the government may be bringing forward the establishment of a unitary Council with perhaps only a single Councillor representing Brandon which he was not in favour of. They also put forward their view of the proposed 40mph speed limit on the B1107 Thetford Road. In the resident's view if this speed limit is adopted then it may not be fully enforced. The resident also enquired if the council was making any contingency arrangements for a lower precept due to increased unemployment in the area. Cllr Wittam replied commenting that he was aware of discussions regarding the establishment of a unitary Council and was not in favour of it either. However, he considered the B1107 and Bury Road as being dangerous roads which would benefit speed reductions. Cllr Wittam also advised that discussions would be taking place regarding precept and emergency planning and further information would be available in due course. Another resident commented that the Clerks report did not appear on the website. The Clerk is to investigate this.
