Parking on School Lane/ Banbury Road stops drivers, cyclist, horse riders, from having an unobstructed view of any on-coming traffic before they pull out. District Cllr Rock will liaise with the Police and ask they pay the area attention.

#### 7. District and County Councillor Reports

**District Clir Rock** – had circulated his report prior to the meeting. Main points, if anyone if missing one of the new "little" green bins they need to contact Streetscene at Stratford District Council. Parliament has agreed the recent Boundary Review. Ladbroke will be placed with Harbury. Clir Rock confirmed the landowner of the plot possibly being considered for a self-build site in Windmill Lane has approached him. Given the Site Allocation Plan (SAP) both local needs housing and custom self-build policies would lend little weight to a development of additional housing in Ladbroke, but it would be up to any potential developer to make an application.

**County Clir Kettle** – advised he has had a verbal response from Warwickshire County Council regarding the grant of £8.4M from the Department of Transport for road safety projects where communities are impacted upon by HS2. Ladbroke has been assessed by WCCs Road Safety Team and does not qualify for any funding. Clir Kettle is happy to consider using his Clir Highways grant to fund some improvements.

It was agreed the Parish council will ask Cllr Kettle to consider funding the following on the entrance to Ladbroke from Bishops Itchington/Deppers Bridge: - painting chevrons onto the road surface, repainting the three SLOW signs on the road and installing village gates (white gates with a large 30 mph sign in the middle)
