



300 CLUB

Terms & Conditions

1. The 300 Club will operate as a Private Society Lottery.
2. The draw will take place on Tuesday of each week commencing on Tuesday 3rd October 2023. At least one committee member will be present at the draw but there will always be an independent person in attendance to witness the draw and to certify the results.
3. Any club member over 18 years of age can subscribe to the 300 Club. Non SIBC members over 18, may also subscribe but the application can only be completed on the club premises.
4. Members must fill in an application form which will include the bank details of where any prizes will be sent. It is the responsibility of the member to advise the 300 club administrator of any changes to that bank account. The club shall not be responsible for any payments made where incorrect bank account details have been provided by the member.
5. The subscription to the 300 Club for one number shall be £2 per week payable weekly in advance by Standing Order (no other methods of payment will be accepted). Payments must be made on the Wednesday prior to the draw on the following Tuesday. This will give members one number which will be placed the draw for that week. This number shall remain the member's provided their subscription is up to date. Members may have multiple subscriptions.
6. The 300 Club will be run on a weekly basis. There is no provision to opt in/out on a week by week basis.
7. Registers will be kept recording the name and address of each member and the number(s) allocated to them.
8. Numbers entered into a draw will depend on the number of subscriptions for that week, i.e. for up to 99 subscriptions numbers 000-099 will be entered, 100 to 199 subscriptions numbers 000-199 will be entered and 200 to 299 subscriptions numbers 000 to 299 will be in the draw. This will reduce the chances of too many rollovers occurring.
9. In the event of a winning number being unsold then that prize will be rolled over into the following week's prize fund.
10. Each weekly draw will take place at the Spalding Indoor Bowls club in the presence of at least three people including one committee member. Draws scheduled to take place during holidays will be done whenever practical.
11. The weekly prize fund will be 50% of the weekly income— there will be two prizes i.e.:-
 1. 1st prize = 35% of the weekly fund
 2. 2nd prize = 15% of the weekly fund
12. The 300 Club Administrators will make all reasonable efforts to pay prizes to the winners within a reasonable period after the weekly draw.
13. Prize winners will be notified in via email and payment will be made by BACS to the account details given at registration. Prize winning numbers will also be listed on the club website after each draw.

14. The allocation of numbers and draw results will also be available from the scheme secretary on request.
15. The decision of the 300 Club Administrators shall be final in all matters requiring adjudication.
16. The 300 Club Administrators shall also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 300 Club members as is necessary.
