KEMBERTON PARISH COUNCIL

Minutes of Parish Council Meeting held in Kemberton Village Hall on Wednesday 8th May 2019 at 7.30pm.

1. ELECTION OF CHAIR

- Nomination for Chair of the Council
 Cllr Phillip Jones nominated Cllr Martyn Bidgood to be Chair for the upcoming year.
 This was seconded by Cllr Giles Greenwood. All in Favour.
- b) Cllr Martyn Bidgood signed the Declaration of Office and resumed the Chair.

2. ELECTION OF VICE-CHAIR

- Nomination for the Vice Chair of the Council Cllr Giles Greenwood nominated Cllr James Rennsion to be Vice-Chair for the upcoming year.
 - This was seconded by Cllr Mary Wright. All in Favour.
- b) Cllr James Rennison signed the Declaration of Office to continue as Vice-Chair for the upcoming year.

3. CHAIR WELCOME AND ANNOUNCEMENTS

Cllr Martyn Bidgood welcomed everyone to the meeting.

4. APOLOGIES

5. DISCLOSABLE PECUNIARY INTERESTS

Cllr James Rennison declared a pecuniary interest in the Item 14, as the applicant for Planning Permission at Wrenmoor Lodge.

It was noted by the Parish Clerk that Planning Permission had been Granted for this application between the issuing of the Agenda and the meeting.

7. REPORT FROM SHROPSHIRE COUNCILLOR

It was noted that Severn Trent had unblocked the drain on Field Lane.

The drain on Grooms Lane is still blocked. Councillors requested that the Parish Clerk write to the Highways department at Shropshire Council to ask for action.

9. MINUTES

It was Proposed by Cllr Phillip Jones that the minutes of the meeting of 13th March 2019 be approved and signed. Seconded by Cllr Mark Lea, **All in Favour.**

10. MATTERS ARISING

11. HIGHWAYS

1) Condition of Local Roads

Cllr Martyn Bidgood, in the Chair, said that the state of the roads is still a concern. Councillors remarked Hall Lane is very bad, with small potholes now more like a trench, and Field Lane is impassable in places. Grindle Road is also very bad. Cllr Mark Lea commented that a member of the public had written to Shropshire Councillor Michael Wood, copying in the Parish Council, criticising the quality of repair work and the waste of money. What little work has been done is inadequate. The answer that there is not much money is not satisfactory for a comment about wasting money.

Cllr James Rennison commented that the A442 to Bridgnorth is in a poor state, and if an A road cannot be done there is no hope for lanes.

Cllr Mary Wright commented on flat bed lorries not leaving much space for other vehicles on the lanes. Cllr Mark Lea said that one of the problems was Sat Nav and questioned if a 'not suitable for Sat Nav' notice might be helpful.

2) Road Junction

Cllr Martyn Bidgood as Chair has followed up with the PCC (Police and Crime Commissioner) about the Safer Roads Fund. The budget has been carried over into the next financial year up until March 2020, and the PCC Office will be accepting bids. A response was been received from the Highways Department on 15th April, any sign would have to conform to traffic regulations. It can be progressed if the Parish Council let the department know what kind of sign they want installed. Possibilities were discussed, including a message about the junction similar to that seen at Bishop's Wood in Staffordshire or the Upton Crossroads on the Wolverhampton to Shifnal Road (A464). A flashing message about speed would not be as effective as the junction is national speed limit.

It was agreed that the Parish Clerk will follow up these suggestions and find out information about what is feasible prior to the next meeting.

3) Visitors on and by the junction

The Chair had spoken to Shropshire Council about the impact on visibility with visitors using a temporary site near the junction. Cllr Mark Lea said it had the effect of slowing down traffic. On departure the site was left tidy.

12. RENEW

Councillors expressed disappointment that two years on from the Planning Inspector's decision there are still issues. Local residents have expressed concern about inappropriate vehicles on the lane by the site. The Parish Clerk has been contacted by one local resident several times, and Councillors have also been contacted by members of the public about the matter.

The Parish Council has written to the M.P and Shropshire Council, and Councillors questioned the remaining courses of action. Cllr Mary Wright suggested that the Parish Council writes to the MD of Renew. It was agreed by all present to write to him highlighting that the Parish Council receives continuing public complaints about Renew's activities, and would like to know the timescale for final completion of the move.

Cllr Phil Jones said that a Renew flatpack vehicle comes through the village every day.

13. CORRESPONDENCE

Information from the PCC's Office about the roll out of Smartwater had been sent out via email. Councillor Giles Greenwood had asked for more information.

The Parish Clerk reported that she had spoken to the PCC's office and had been advised that taking part in the programme would require a 75% take up of households. Councillors expressed the view that this would be a high take-up particularly as some households already have smart water kits.

16. SHIFNAL PLACE PLAN

The updated version of the Shifnal Place Plan will be published in November.

Councillors Martyn Bidgood and Mark Lea, and the Parish Clerk, were present at a Place Plan Review Meeting held in Shifnal Fire Station on 25th March.

Cllr Mark Lea reported that the meeting had worked through a document with about 50 things to consider. He had mentioned drainage and water courses, whilst Cllr Martyn Bidgood had mentioned the junction. The meeting had been conducted on the assumption that the planning was going to go ahead, Shropshire Council said it had to be prepared. Consequences raised by those present included parking and medical surgery capacity.

Cllr Mark Lea said it had been an ill-tempered meeting. He expressed the view that planners work it all out like it is an A-Level Geography project, but in reality it will turn out nothing like it.

Cllr Martyn Bidgood said that there had been frustration all around. Shifnal Town Councillors had expressed frustration about lack of enforcement of the lorry ban.
