

## Perceptions of travel safety and support for potential interventions in the Wallops

An 80-item survey was developed to determine the levels of safety concern, experience and support for potential interventions to improve safety and accessibility while travelling in and around the parishes of Nether Wallop and Over Wallop.

The survey, available both electronically and on paper, was advertised widely on social media (Nextdoor/Facebook), parish magazine and via email to residents signed up to 'the pump'. Of the 164 responses received both Over Wallop (53%) and Nether Wallop (47%) were well represented. Due to the non-targeted approach, the response rate could not be determined. However, the absolute numbers represent 5-10% of parishioners in each parish and likely a higher proportion of households. The sample was represented by a variety of road users. Full results of the survey are attached.

More than half of respondents reported having at least one near miss or accident. In total, 99 near misses and 15 accidents were reported in the area. A significant proportion occurred to vulnerable road users, with the remainder occurring while driving. 53 of these incidents resulted in locals being very shaken, and 17 incidents involving and upsetting local children. In addition, 9 pets were reported to have been killed. Reducing these occurrences is essential to enable the desired modal shift to make the parishes happier, safer and more pleasant places to live.

Of those who responded to the survey, the vast majority are worried about speeding in their areas (86% in Over Wallop and 74% in Nether Wallop). The ways to address this are many and the recommendations of the working group are consistent with the responses from the survey and build on the understanding of the working group. The actions lie partially within the control of the parishes (eg. speedwatch groups) but most require engagement with HCC.

In conclusion, there is clear evidence that travel safety in the parishes is a significant problem affecting a high proportion of the parishioners responding to the survey. The attached list of recommendations based on support for specific interventions demonstrates that there is an opportunity to improve conditions for those travelling in the parishes. In light of the wider issues relating to inactivity and climate change it is therefore recommended that all locally supported avenues to improve travel safety are sought.
