



**Make a Will Month  
October 2021  
Key Points**

1. For your appointment to qualify for Make a Will month, you need to make your booking by Friday 24 September for an appointment to take between Friday 1 October and Friday 29 October. Occasionally some appointments occur outside of these times, which are at the discretion of each Solicitor.
2. All seven participating Solicitors are donating their time for free, and will invite clients to make a voluntary, suggested donation to Heart of Kent Hospice, in return for their professional Will writing services.
3. The suggested donations all represent a substantial discount on the normal commercial rates charged by each participating Solicitors. Suggested donations are as follows:
  - £120 for a change to an existing Will
  - £160 for a new single Will
  - £200 for a pair of new mirror Wills
4. You are welcome to make any size donation to Heart of Kent Hospice. In recent years, a number of clients have donated the commercial rate the Solicitor would normally charge. Your Solicitor can advise you on their individual commercial rates.

6. If you are a UK Taxpayer, Heart of Kent Hospice will be able to claim an additional 25% Gift aid on your donation. A Gift aid form is enclosed on the donation envelope which will be sent to you in an information pack after booking your appointment. Alternatively, you can Gift aid your donation online.
7. Your Solicitor will inform you of any additional costs which may be associated with complex and tax planning Wills or estates, or those that need Trusts creating. These are not covered by this scheme and can be paid to the Solicitor separately in addition to any donation made to the Hospice.
8. Heart of Kent Hospice understands that providing for family and friends is your key consideration when writing your Will, and although we very much hope you will consider making a gift to us, it is not a condition of the scheme.
