001.16 **Apologies for Absence** - Jenny Watts – working in New Zealand. Jane Mullan – clerk, had to attend a funeral at short notice.

002.16 Disclosures of interest.

There were no disclosures of interest.

003.16 **Minutes** – to agree the minutes of 15th December 2015 as a true record.

The minutes were agreed with one amendment to paragraph 159.15 and then signed by the Chairman as a true record of the meeting of 15th December 2015.

004.16 Reports to be received

- i) NFDC Cllr Diane Andrews
 - a) Reorganisation of NFDC from the top down continues.
 - b) NFDC have approved 35 new affordable homes at Calmore which will be offered to persons currently on the housing list.
 - c) Clean for the Queen 4-6th March. A national initiative to pick litter.
 - d) Volunteers required for one-on-one teaching of elementary computer skills. The project is to be based in Totton. Also a scheme to offer awards for volunteering has been establish and the Council were asked if it wished to consider nominating anyone.

006.16 **Public Forum** An opportunity for the public to make known the council any issues of concern, or to make comment on items on the Agenda including Planning Applications.

Mr Peter Reynolds from Brook raised the issue of fencing work which had completed by the Verderers on open land at Brook without any prior consultation with the Parish Council. It

was agreed that the Chairman would write to the Verderers to ask that in future the Parish Council should be consulted prior to any work that might affect local residents.

Mr Reynolds also reported that one of the obsolete 40mph signs on the road surface in Brook which had been painted-out was now visible again. This will be reported to the appropriate Highway Authority department by SB.

Mr Reynolds also mentioned a tree branch on the forest which needed pruning. He was meeting with the Forestry Commission and it was agreed that he would come back to the Parish Council if he could not resolve the problem with the Commission.

Ms Gemma Wilks applied to the Council on behalf of Nomansland Pre-school for a grant of £500 to fund a fourth member of staff so that the children could be taken regularly into Bramshaw Woods as part of the learning experience. She confirmed that on average over the last 10 years between 15-20% of the children attending the Pre-school are from Bramshaw Parish. Because the Clerk was absent it was not possible to confirm the current state of the Grants budget so it was agreed that the Pre-school should be granted £250 with the possibility to make a further application in April/ May this year if funds were still required.

David Johnson mentioned that Forest Views will publish its last edition in March unless a new Editor can be found. It was agreed that Charmian Dominey would be invited to the next meeting to discuss if the Council may assist in recruiting.

SB reported that the blocked drains which were the cause had been due to be cleared, but owing to cuts the work had been removed from the Highway Authority work programme; however she understood the work had now been returned to the list. The Council resolved to write to both Tim Lawton at the Highway Authority and Cllr Edward Heron to express the need for urgency of the work to resolve the situation (action Clerk).
