NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, John Forely a Member of the UP HATHERLEY PARISH COUNCIL, set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

PART A

DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their husband or wife, civil partner or of any person with whom they are living as if husband or wife or as civil partners when such interests are known by them.

1. EMPLOYMENT, OFFICE, TRADE, PROFESSION OR VOCATION

Any employment, office, trade, profession or vocation carried on by you, or those persons referred to above, for profit or gain.

2. SPONSORSHIP

Any payment or provision of any other financial benefit (other than from Up Hatherley Parish Council) made or provided within the last 12 months in respect of expenses you (or any of the persons referred to above) have incurred in carrying out your duties as a Member or towards your election expenses. This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and Up Hatherley Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

4. LAND

Any beneficial interest in land which is within the area of Up Hatherley Parish Council (this includes your home or any land or buildings from which you, or the persons referred to above, receive rent).

5. LICENCES

Any licence (alone or jointly with others) to occupy land in the area of Up Hatherley Parish Council for a month or longer.

6. CORPORATE TENANCIES

Any tenancy where, to your knowledge, the landlord is Up Hatherley Parish Council and the tenant is a body in which you, or the persons referred to above, has a beneficial interest.

7. SECURITIES

Any beneficial interest in securities of a body where:

- (a) that body, to your knowledge, has a place of business or land in the area of Up Hatherley Parish Council and
- (b) either:-
 - i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

8. MANAGEMENT OR CONTROL

Any body which you are in a position of general control or management and to which you are appointed or nominated by the Council.

- b) directed to charitable purposes; or
- c) one of whose principal purposes includes the influence of public opinion or policy (including any Political Party or Trade Union) of which you are a Member or in a position of general control or management.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- 1) omit information that ought to be given in this Notice;
- 2) provide information that is materially false or misleading;
- 3) fail to provide written notification to the Monitoring Officer of any change in my interests contained in this Notice within 28 days of my becoming aware of such change of circumstances.

I understand that under Section 29 of the Localism Act 2011 there is a legal requirement for the Reg [REDACTED] to be published on the internet.
