- Attached to the agenda is the council's Annual Receipts and Payments Account for the year ended 31<sup>st</sup> March 2015. This statement compares final receipts and payments for 2014/2015 against 2013/2014 and also against the budget for 2014/2015. It is a matter of fact but councillors have the opportunity to ask questions.
- Once satisfied, the council has to formally resolve to approve the Audit Commission's Statutory Annual Return and Governance Statement for the year.
- Prior to the formal approval, the Council is required by Council Standing Orders and the Accounts and Audit Regulations 1993 to carry out an annual review of Financial Regulations and a Risk Assessment. Councillors have already reviewed Financial Regulations and the Risk Management Statement 2014/2015 during the year. The Risk Management Statement 2015/2016 will be presented to a future meeting of the council.
- The Council then has to make the formal resolution to approve the Annual Return for the year ended 31<sup>st</sup> March 2015 and the Chairman and Responsible Finance Officer have to sign it. Included with the Return are the bank reconciliation statement and a statement of variances between the previous year 2013/2014 and 2014/2015, both are required by the Accounts and Audit Regulations 2011. All are attached at **Appendix**. Also included is the Final Internal Audit Report with the Audit Plan and findings. Once approved, the Annual Return will be sent to Littlejohn for external audit before the 8<sup>th</sup> June deadline.
