# Minutes of the meeting held on Monday 3<sup>rd</sup> July 2017

### 17.042 Welcome by the Chairman

The Chairman welcomed everyone to the meeting.

<u>17.043 Apologies:</u> Cllr J. Taylor and B. Taylor. **Resolved** to accept the apologies received.

### 17.045 Public Session:

The Meeting is to be adjourned for 15 minutes to allow questions to the Chair from Members of the Public. No questions raised.

#### 17.047 Matters Arising from those Minutes:

- (a) Speeding issues within the village. The Council discussed the issue and the recent traffic counters which had appeared at various locations within the village. **Resolved** that the Clerk would contact the School to see if they had contacted TWC on this matter.
- **(b) Flower troughs by youth Club.** The Council was informed that there could be possible donations of plants coming forward from local businesses and that Cllr Millard had already planted some bedding plants in the troughs after Cllrs J and B Taylor had cleared them.

Resolved to spend up to £50 on bedding plants, compost and watering can.

- (a) Asset Register The Council to review and update its Asset Register. Resolved to agree the Asset Register for 2017/18 after amendments. Resolved to look further into fire safety / health and safety / PAT testing for the Talbot Centre.
- **(b) Wild Flower Seeds** The Council to consider purchasing wild flower seeds (for next year) for the gateway signs (stone features) as they are more robust and shouldn't need constant watering, also being very beneficial for bees and butterflies.

- **(c) Street Lights:** The council was informed that a meeting was to be held shortly with both Prysmian and TWC to discuss further.
- **(d) Bus Shelters:** It was reported that there had been a couple of complaints regarding the state of the shelters, possibly down to them not being jet washed. Cllr A. Baker will be looking into this. There are currently three shelters left to be completed in the programme of works.
- **(e) Parish Plan:** Council was informed that we are now two thirds of the way through the process, currently in regulation 14, which ends 14<sup>th</sup> July. We have received a few comments but would be nice to have more. It was also noted that the council has received written acknowledgement from the local MP in support of our plan.
