

Minutes of the Parish Council Meeting held in the Village Hall on Thursday 14th March 2013 at 7.30pm

Present

Village Hall

Jubilee tapestry – Cllr Stewart has donated £200 to wards the frame – a quote for approx £180 has been received – agreed to send a letter of thanks

Roads

Mud on Radley Road – the Chairman has spoken to the local farmers and NCC highways – NCC have cleaned the road and any further cleaning will be done at the farmers expense

Erosion at the end of Challends farm lane – from there towards Oxton NCC have agreed to repair the worst sections with crushed road stone

Damaged verges along Radley Road – NCC suggested hard standing /passing places. After discussion agreed not to as the farmers have agreed to repair the damage when work is finished and the ground drier

New grit bin – agreed to ask NCC to consult with the land owner about the position near to Manor Farm

Oxton end of Radley Road – NCC highways Exploratory team are to look into the running water, in the next couple of weeks

Drains on The Turnpike – work to start near Halam Beck on 25th March

Cllr Laughton arrived

Renaming Radley Road

After a short discussion – agreed to put on the agenda for the Parish Meeting – with suggestions of adding another sign saying previously known as Church Lane

Open Meeting

Sale of land on School Lane – the potential sale of 2 square metres of NCC land – gives neither the School nor PC a say in this. After any such sale the school does not require the security fencing to be reinstated

Cllr Laughton – reported that N&SDC will be setting a zero increase for their part of the Council tax
