Minutes of the Ivinghoe Parish Council Meeting held at Ivinghoe Town Hall on Monday 6th June 2022 at 7.15pm.

C/089/22. Chairman's Welcome.

The Chairman stated Ivinghoe Parish Council had a successful Jubilee event the Chairman was disappointed the National Trust would not allow the beacon to be lit on Ivinghoe Beacon. The Chairman thanked the Vice Chairman for reading the proclamation and Councillor Lott for lighting the Beacon and the Parish Clerk for organising the event.

C/090/22. Public Question Time.

C/091/22. Apologies for Absence.

Apologies were received and accepted from Councillors Bexson and Roach.

C/092/22. Declarations of Interest or Dispensations from Councillors Relating to this Meeting.

Councillor Lott declared he has an allotment.

C/093/22. To receive Reports from the Buckinghamshire Councillors.

Not in attendance.

C/094/22. To Approve the Minutes of the Ivinghoe Parish Council Meeting held on the 9th May 2022.

The minutes were approved by the Council and the Chairman signed the minutes as true and accurate.

C/095/22. Planning Applications:

22/01640/APP Removal of existing industrial structures and paraphernalia. Erection of a dwelling – Willow Farm, Ivinghoe Aston, Ivinghoe, Bucks, LU7 9DF.

No Comment PROPOSED BY Councillor Ketteridge and SECONDED BY Councillor Bamber and carried unanimously.

C/096/22. Footpaths, Bridleways, Trees and Playgrounds.

The Lower Lawn has been cut and the cherry trees cut back.

The footpath to Great Gap is obscured and will be reported to Buckinghamshire Council.

The bridleway is overgrown and has been suggested as an alternative route to the Maud Janes footpath closure, this will be reported to Buckinghamshire Council.

Playgrounds – the Parish Council has received a complaint there is meant to be a 12mm gap between the gate and the fence, the gap exceeds minimum standard.

Ivinghoe Aston footpath – Councillor Bexson and Ketteridge will meet with the contractor who will be installing a new footpath with the landowner.

The Ivinghoe Aston layby has been prepared for the new hedge and the Chairman will speak to the resident who will do the planting.

The foodbank storage has been moved to Ivinghoe Old School Village Hub, the organisers have asked if they can have vehicular access across the Lawn twice a week. It was agreed to allow access for two cars twice a week for a maximum of ten minutes drop-off time or pick-up times. This will be a temporary arrangement with no right of way the Clerk will write to the organisers.

Ivinghoe Lawn Bookings – over the next few months there a nine Lawn Bookings, Councillor Lott will open the Lawn for the bookings except the 23rd of July which the Chairman will open the Lawn for.

Noticeboards – it was agreed to ask Brian Rogers to attend to the noticeboards.

C/097/22. Highways, Streets and Transport (including Speedwatch).

It was noted that two members of the public cut the ivy back off the Church wall and the parish council were thankful.

Speedwatch – Councillor Lott mentioned there has been an increase in speeding vehicles.

Wilder Verges – Buckinghamshire Council have confirmed Ivinghoe Parish is taking part in the wilder verges pilot. Buckinghamshire Council are using the wrong maps and not including the 30MPH areas, the Chairman will speak to Transport for Bucks.

Ivinghoe Aston road naming a discussion took place and the different suggestions were read by Councillors Ketteridge and Lott. The suggested names will be sent to Bucks Council and the Housing Trust

Allotment Open Day – it was agreed to allow the Allotment Open Day on 14th August 2022.

The Chairman and Councillor Jellis will inspect the allotments including the tree heights. The allotment terms and conditions will be amended to include ponds.
