<u>Draft Minutes of the Ordinary of the Parish Council held on Thursday 17th</u> <u>November 2022 at 7.30pm</u> Held at St John's Church, Bishop Thornton.

(2022 - 23 – 091) Present were Cllr Carolyn Sandford (Chair), Cllr Nick Tither (Vice Chair), Cllr. Julia Fulford, Cllr. Kevin Reynard & Cllr. Blair Robertson.

(2022 - 23 - 092) Also present were David Taylor, Clerk. There were no members of the public.

(2022 - 23 - 093) No apologies were received.

(2022 - 23 – 094) It was **resolved** that the minutes of the meetings held on 13th October 2022 having been circulated for consideration beforehand were true and correct records. The Chair was authorised to sign them accordingly.

(2022 - 23 – 095) It was **reported** to the Clerk that some, if not most documents that were sent out prior to meetings were not being received or if they were they unable to be opened by some of the Councillors present. The Clerk said that he would investigate this and seek an alternative means of delivery if necessary.

(2022 - 23 – 096) The Clerk **heard** that in a recent medical emergency in the community it was apparent that many residents do not know the whereabouts of the defibrillators that have been installed by the Parish Council. It was **resolved** that the Clerk shall ensure that the Yorkshire Ambulance Service know the whereabouts of the units. Also that he should investigate the distribution of flyers and posters locally.

Reports:

(2022 - 23 - 097) The meeting **heard** with sadness that Cllr Margaret Atkinson, of the Harrogate Borough Council and North Yorkshire County Council had recently passed away. The Councillors asked the Clerk to write to Margaret's husband and offer their condolences. (2022 - 23 - 098) Cllr Tither **reported** on the Shaw Mills traffic situation that:-

- a. There are now "No footway" signs installed on the bridge.
- b. The replacement rumble strips have still not been installed.
- c. The white lines through the village have still not been installed.

These items have been promised by Area 6 at North Yorkshire Highways by the end of 2022 and paid for by grant funding by the Parish Council.

It was **resolved** that the Clerk should write to Area 6 and ask for the work to be finished as agreed.

(2022 - 23 — 099) Cllr Sandford **reported** on the public right of way (PROW) at Flask House Farm that:-

- a. Gate had been locked and an electric fence installed across the PROW in question.
- b. Cllr Sandford had written to NYCC PROW department by email who she felt were not particularly helpful. They told her to make her comments through the 'portal'.
- c. The electric fence has since been removed and the gate unlocked.

Correspondence:

(2022 - 23 – 100) Received by email - The YLCA re: A model councillor-officer Protocol was read, considered and noted. The contents were agreed in principle.

(2022 - 23 – 101) Received by email – Commissioner Zoe re: appeal for Parents to have early & positive conversations with their Teens was read, considered and noted.

- **(2022 23 102) Received** by email 20mph in 2023 Budget: Ask County Councillors for at least £1 million in Phase 1 was read, considered and noted. It was **resolved** that the Clerk shall write to the Clerks of Markington with Wallerthwaite, Clint cum Hamlets and Grantley & Sawley Parish Councils and seek their co-operation in working together to achieve this goal of `20s plenty'.
- (2022 23 103) Received by email from YLCA re: North Yorkshire Council was read, considered and noted.

Financial Matters:

- **(2022 23 104)** It was **resolved** that the Clerk should draw up a draft budget for the forthcoming year 2023 2024. There should be a minimal increase in the precept, if at all. The budget should maintain a correct level of reserves and provide for the maintenance of Parish assets.
- (2022 23 105) The accounts for payment as listed on "Appendix A", below, were approved for payment.
- **(2022 23 106)** A Bank Reconciliation to the period 17^{th} December 2022_(including all payments up to and over £100.00) was **received and unanimously approved**. The Chair signed it accordingly. This appears at **"Appendix B"**, below.
- (2022 23 107) A Spending v Budget report to the period 17th December 2022_was received and approved by the Council.

Planning Matters:

- (2022 23 108) Cllr Tither **said** that the YLCA training seminar on the planning system was very useful and informative. He will circulate the presentation slides to councillors for information.
- **(2022 23 109) Planning Application** 22/02007/ Conversion of previous farmhouse and outbuildings, etc. Far Gill Moor Farm Warsill. HG3 3LF. Mr & Mrs Simon YoungIt was resolved that the Clerk shall write a letter to the Planning Authority asking for their reasoning in the judgement.
- (2022 23 110) Councillors questioned the planning application on Throstle Nest Farm, say that they could not find the application. The Clerk is to investigate and report back.
- (2022 23 111) With regard to "The Mill" development at Shaw Mills, attention was drawn to the Design and access statement there is very serious feeling in the community that the conditions regarding parking will be implemented. Cllr Tither said that there will be a site meeting with the developers. This will be organised along with HBC.
- (2022 23 112) It was **confirmed** that the next regular meeting of the Parish Council would be an ordinary meeting on Tuesday January 17^{th} 2023 at 7.30pm.
- (2022 23 113) It was **resolved** to approve the schedule of meetings for 2023, which appears at "**Appendix D**", below. The Clerk shall inform both Warsill Parish Hall and St Johns Church, Bishop Thornton.
- (2022 23 114) The meeting closed at 9.55pm.
