- F/15/76603 18 Drake Road two storey rear extension and single storey rear extension object on the grounds that the 2 storey extension was overdevelopment and concern at the impact of the one storey extension
- F/15/76687 12 Fair Oak Road two storey side extension no objection
- F/15/76567 38 Strawberry Mead convert existing garage to habitable accommodation no objection
- N/15/76784 75 Church Road fell one Ash and one Sycamore and replace with one Silver Birch object as crown reduction should suffice
- C/15/76575 River Inn, Fair Oak Road change of part car park use to hand car wash and valeting with installation of a canopy and erection of a storage container object on the grounds of loss of car parking space in this popular and busy car park, concern at the likely increased traffic volume to/from the busy main road, concern at the impact of water/detergent run off into the local river and drainage system and it should be noted that this area is known to flood in Winter
- A/15/76576 River Inn, Fair Oak Road display 2 non-illuminated free-standing signs no objection
