Minutes of Parish Council Meeting held on 9th April
8.15 pm in the Memorial Hall, Hedgerley

Community Submissions – none at this time

- 1. To approve Minutes of Meeting held on 12th March 2018 which had been previously published on the noticeboards and website.**
Minutes were approved as a true record, and signed.
- 2. County Councillor**
Report sent – BG said that she would be getting an amount of money specifically for the use of the repair of potholes. We will hope to know more details on this shortly.
Hole repairs urgently required in Hedgerley – 1. Costtage Park Road; 2. Stevenson Road; 3. Kiln Lane.
- 3. District Councillor**
Would be attending the meeting this evening at SBDC offices regarding the single unitary Council.
- 4. County Council Matters**
Overgrown hedges in Village Lane. – Clerk told Councillors that she had written to the two residents of the properties indicated by our local technician from Highways Department. One of the properties had complied, the other had not, and the Clerk will now have to inform the LAT for further action.

 - Report was noted, cheques signed.
 - Audit update – Clerk had met with Paul Miller. Accounts were now up to date; arranged another final audit meeting next Wednesday to make sure everything was in order.

All the information is via email and they have provided nineteen pages of instructions. They have mentioned that any contact will mean a charge of £40.

DB noted that SBDC will no longer have a Planning Department at Capswood. In future all Planning will be carried out at Chiltern DC.
