69/2122 PRESENT & APOLOGIES FOR ABSENCE

70/2122 DISCLOSURE OF PECUNIARY INTERESTS & DISPENSATION REQUESTS

 - Cllr. Arthur declared a pecuniary interest in item 80/2122 ref the quote he had submitted to clear the portacabin area.

71/2122 PUBLIC PARTICIPATION SESSION

The applicant spoke re 75/2122 (2) and presented revised plans, in response to feedback from parish council. The revised application falls within permitted development rights and the extension is in line with the house. The bin access isn't blocked as bins are accessed through the other side gate. Cllr. Dickinson asked applicant about the fence and the applicant said the fence is not to be altered and the distance of the extension from the fence is circa 2.5 metres. Cllr. Dickinson asked about the views of the house on other side and the applicant informed the meeting that he had spoken to them and they had no concerns.

72/2122 **MINUTES**

- (i) Minutes of the Council Meeting dated 7th September 2021 it was **RESOLVED** to confirm the minutes as being a correct record and authorise the chairman to sign them.
- (ii) Minutes of the CIL working group dated 16th September 2021 noted. It was agreed to task the CIL group to look into a small community building.

73/2122 **REPORTS**

- *a)* Police Report concern was expressed re data not being locally relevant in the quarterly report and it was agreed to make a complaint.
- b) Shropshire Council Cllr. Potter reported on the following:
 - Pedestrianisation of Shrewsbury keen to get views of rural residents. New pedestrianisation trial of Wyle Cop. Climate team want 10% of highways budget put into active travel. Parish Council noted that Park and Ride usage down since pandemic and it needs to be more regular ideally but people who used it are not as comfortable since the pandemic. Concern was expressed re negative economic impact from decreased traffic being allowed into town and it was felt that there is need to balance pedestrianisation with loss of parking/economic issues. Cllr. Potter said he is keen to focus the Big Town Plan

- outwards, to villages served by Shrewsbury and ensure it is not just a plan by Shrewsbury residents for Shrewsbury.
- *SC Finances* still under pressure budgetary pressure on council circa £50 million in next 3 years. Hoping Shropshire may feature in Levelling Up plans. Capital projects may have to be paused to reduce revenue pressure re borrowing. Looking to cut people budget
- *Locally* relatively quiet.
- *Policing* Cllr. Potter to speak to police re communication to the community when a major incident takes place e.g. the recent incident on Nesscliffe Hill. Speak to police re communication when an incident in the area.
- Youth Club club gradually growing, now 14 on the books now. Nine years upwards and 2 from Baschurch.
- d) Great Mess to Little Mess Cllr. Diggory reported there is circa £30 in bank. A pick is planned for end of October. No fly tips have been reported.

76/2122 **PARISH MATTERS** – to consider updates and new matters

- a) Highways' maintenance matter
 - Road condition at Ruyton plus Gibraltar Lane.
 - Hedge on north side of village needs doing. Cllr. Diggory has spoken to a hedge contractor with a view to doing 3 or 4 safety issues.
 - It was agreed to clarify with Graham Taylor if the path clearance, as part of EMG works, includes Nesscliffe Hotel to Great Ness crossroads.
 - Concrete at bus shelter need doing.
- b) S50 works, VAS and crossings the clerk presented some of the S50 plans but some are awaited. There are issues with the Bluetooth connection on the VAS which the clerk is investigating to enable data to be downloaded. The crossing plans were noted and the work is to be done when the other S50 application items are submitted, to save application fees. A quote for the crossings has previously been agreed.
- c) Noticeboards delivery date and fitting date awaited.
- d) 30mph stickers (Cllr. Mullis) it was agreed to ask SC is we buy 30mph stickers to put on lampposts.
- e) Lorries speeding a response had been received from MJ Refrigeration who had apologised
 and said he would remind his drivers they are to use the bypass not come through Nesscliffe
 village.
- f) Draft Local Lettings Plan for affordable homes at Hopton Park it was agreed to ask for the following amendments:
 - Applicants to have resided in parish 2 years not 3 years.
 - Re the bungalows and an enquiry about them being used for persons with disabilities, it was agreed that the parish council's preference that they be first advertised for 6 weeks for local need, then 6 weeks for disabled persons, then general need.
- g) Sign for Drover's Road, Great Ness the sign wording was approved, subject to S50 approval.

- h) Book swap (Cllr. Mullis) –a book swap box has been placed with the food bank. There have been some swaps but some concerns re if it will work in terms of capacity and choice. It was agreed to continue to trial for a further month or two and consider putting a suggestions list.
- *i)* Reports of other parish matters
 - Cllr. Turner suggested a donation to Samaritans Shrewsbury branch of £50, in light of recent incidence re Nesscliffe Hill. It was also agreed to suggest to SC Countryside Team that a notice with the Samaritans number is placed at the site. Cllr. Peters suggested the Great Ness Charity contributes to. It was **RESOLVED** to donate £100 (£50 will be given on behalf of the charity who will reimburse the parish council once the banking issue they have is resolved). It was further **RESOLVED** to pay for the aforementioned signage at the hill and seek advice from the Samaritans on signage.
 - Little Ness war memorial damage a lorry had struck the war memorial. Guy Davies had kindly arranged a repair and intercepted the driver it was agreed to write and thank him,
