LOCAL GREEN SPACES (1)

- The Neighbourhood Plan can offer special protection against development for certain green areas of particular importance known as "Local Green Spaces".
- The designation should only be used:
 - > where the green space is in reasonably close proximity to the community it serves
 - > where the green area is demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife
 - > where the green area concerned is local in character and is not an extensive tract of land
- We asked the community in March this year to nominate those green areas in Exbourne that they would like designated as Local Green Spaces. The nominations are shown on the map opposite. The various reasons given by the nominees for why they are special are set out in the table below:


