### 3 TO RECEIVE A REPORT FROM SON LDR GEARY - RAF LAKENHEATH

Sqn Ldr Geary did not attend the meeting but wished to report the following items: -

The F35A arrival is planned for this week but is subject to change (weather conditions here and in the US, sea conditions etc).

The Sqn Ldr has been working with Suffolk Police, MOD Police, West Suffolk Council, Suffolk Highways (Network Assurance) and the LRF in an attempt to mitigate the risk of congestion and Road Traffic Accidents, particularly around the A1065, when the F35As arrive later this week. There will be a Suffolk Police and MOD Police presence on the day to deal with any road traffic incidents that may occur. His top tip to local residents is to try and avoid the area on the day of the aircraft arrival.

The 494<sup>th</sup> Fighter Squadron have returned from overseas operations and they currently have a detachment from the 336<sup>th</sup> Fighter Squadron operating from RAF Lakenheath; hence residents will have seen an increase in aircraft sorties over the last couple of weeks.

During 21<sup>st</sup> November, RAF Lakenheath personnel supported 21 Remembrance events around the Counties of Suffolk and Norfolk. Sqn Ldr Geary and Capt. Trujillio-Castrillo thoroughly enjoyed attending the Brandon Remembrance Day Event. It was great to see the community turning out in such large numbers and the vicar did a wonderful job of highlighting the importance that young people play in remembering the fallen – thank you.

RAF Lakenheath and RAF Mildenhall hosted a joint Thanksgiving Eve Service at Ely Cathedral on 24th November and hosted a joint Yuletide Event at RAF Lakenheath on 3rd December.

**TO CONSIDER** the responses from the developer of the Bingo Site re Planning Application DC/21/0761/FUL – Breckland Bingo and Social Club, London Road, Brandon.

A resident read out a letter of correspondence sent to the Chairman on 4<sup>th</sup> December regarding the development of land adjacent to the Church Institute. Copies were made available to Council. Cllr Brabbs outlined the right of access as confirmed by West Suffolk. Cllr Lukaniuk reiterated that the Church and local residents will have continued usage of vehicular access along the pathway. Cllr Brabbs stated that the footpath had been confirmed in 1985 by Suffolk County Council and added that the soakaway which the developer had stated which did not exist had been opened in 2021 and had performed the duty as described by Brandon Town Council previously. He stated that the site had been greatly reduced in area from when the original outline planning permission had been given and therefore the housing density had increased. A general discussion ensued regarding the issues which Brandon Town Council had raised with West Suffolk about the development. Brandon Town Council was not satisfied that these issues had been answered fully. A vote then ensued. A response is to be sent to West Suffolk Planning Department on 14<sup>th</sup> December.
