- 3 Minutes of the Parish Council Meeting held on Wednesday 26 Feb 2014 The minutes were signed by the Vice Chairperson as a true record.

- a) J G Pears (Newark) Ltd.: Nothing to report.
- b) Darlton Play Area: The Clerk reported that Darlton residents were meeting with local businesses and arranging fund raising to contribute to the cost of the play area. The Dunham Bridge Company will reconsider the application for funding in their new financial year which begins in July, but there are no certainties within that application. A pending problem applies in that the play area is overdue a safety inspection and in its' current state would be likely to fail. For that reason the Clerk stressed the importance of having the work carried out sooner rather than later.
- c) Caldecott Home in Fledborough: The Clerk liaised with the Caldecott Foundation in an attempt to arrange quarterly meetings at Dunham Village Hall. No firm dates have been set due to the difficulties with availability of interested parties being able to attend. The Police report received this month indicates that there has been several recent incidents reported to them, these were discussed in length by the Parish Council. No complaints had been received.
- **d) EMAS:** Information exchanged between the Clerk and North Nottinghamshire Community First Responders confirmed that Dunham and District are within their support area. A donation is likely to be made and the amount given will be decided at the next meeting. The Clerk was asked to write and find out what amount of donation is acceptable.
- e) Lengthsman Scheme: The Clerk reported that the Lengthsman Scheme will continue indefinitely with funding already received and surplus from the previous financial year. It is not known at this stage whether or not further funding will be given. A meeting will be arranged to discuss the running of the scheme and interested parties will be informed.

A new programme is necessary and will need technical guidance, installation costs and training applying to the continuation of service to the Parish Council will be claimed through administration costs. The Parish Council agreed to pay for the additional costs.
