Local Government Boundary Commission for England

LGBCE has launched its consultation on the draft recommendations for ward boundaries in Dover. The consultation closes on 13 August 2018.

Eythorne Parish Council put forward a proposal, which has been accepted to have a 3 member ward which includes Aylesham, Eythorne, Shepherdswell with Coldred and Nonington. This is being called Aylesham and Eythorne Ward. If you have another name for the ward please submit that idea.

Reporting to the Police or DDC Community Safety Unit

The introduction of GDPR has made it more complicated for District Councillors and Community Wardens to report second hand information. If you have a concern, complaint or comment, it is better for you to report first hand to the police on 101, or crime-stoppers (if you wish to remain anonymous). The Community Warden still welcomes your calls and can help you through any reporting processes.

Big Conversation Meetings

KCC want to find out if there is a better, more sustainable way of providing transport to rural communities not currently served by commercial operators. They want to explore this in conversation with a number of stakeholders.

KCC are working with transport and technology providers, District/Parish/Town Councils, stakeholder organisations and communities across Kent to identify potential ideas to develop new ways of delivering rural transport.

This is an exciting opportunity for all stakeholders to provide feedback on the ideas presented as KCC develop potential alternative delivery models for rural transport. It is important that they encourage participation within the county to understand the needs of the residents.

Once KCC have explored potential ideas with the market and completed engagement with residents, future delivery models will be further developed.
