- e) Consideration of donation to St Peter's Church roof fund
  Discussion followed around the £1,500 pledge made by the Parish Council to the roof fund. Under Section 137 of the Local Government Act 1972 a Parish Council can spend up to £6.80 per elector in the financial year 2012-13 for the benefit of the community or the area of the parish. Cllr R Small proposed £500 be donated to the fund this financial year and the Chairman seconded. ALL AGREED. The Clerk to contact Mrs Ellis to check details for the Treasurer of the PCC and a letter be sent enclosing the cheque with breakdown (receipt to be requested) ACTION: S Pickard.

- i) Notice of Casual Vacancy The Chairman confirmed that four notices had been posted around the village.
- ii) The Clerk drew the Council's attention to the Dispensation form that NALC advise be completed in order for councillors to discuss the budget and set the precept. To be discussed further at next month's meeting.
- iii) Defects to report Parish Councillors noted potholes from the village boundary at Church Lane Farm to the Church through Top Street; along Low Street and from the bus shelter out along Stokeham Road. Also the safety bollards on Darlton Road through to the A57 have not been replaced, although marked out on the road with yellow paint. The Byway sign on Darlton Road at the junction with Back Lane is also down. **ACTION: S Pickard.**
- iv) Local Bus Service the Chairman advised that the Your Bus service is being terminated at the end of March. Tenders are being received for a new service and more information will be available from 25<sup>th</sup> February 2013.
- v) Street light defect the Chairman noted that after three months a new light has been fitted.
