- **2. Declarations of Interest and Requests for Dispensations** Sue Hartshorn declared interests as the Treasurer of the Village Hall Committee
- 3. Approve Minutes of the previous meeting The minutes for the Annual Parish meeting of Stretton under Fosse and the Annual meeting of the Parish Council were approved. Amendments needed to be made regarding the new positions of the Councillors on the Ordinary meeting minutes. These will be updated and published on the website accordingly and signed at the next meeting.

- 6. To Report on Matters Arising from the Minutes of the last meeting
 - Safer Roads Proposal We've received a receipt of acknowledgement for the funding request. The title of the project is 'Speed-hog Watch'. It is a project planned over one year which involves signs being put up in the village with speed checks before and after for comparison. The proposal includes the participation of an expert panel to give opinions as well to measure perception vs actual speed. The request will be assessed in July and we will be sending policies when approved to add to the proposal and show support.

 - o **Risk Assessment –** approved with no changes
 - Constitution none presented, we need to investigate if we need one or if we are formally constituted by the Local Council
 - Safeguarding approved with changes to add 'staff' to list of responsible people
 - Diversity approved with changes to add 'staff' to list of responsible people
 - **Lighting repairs** We have lights on telegraph poles, self-standing support, and two mounted on houses so they are all different and we need to decided how to proceed.
 - Confirm our current contract or 'service level agreement' with Eon as our main maintenance provider
 - Plan a way forward to collect and manage quotes for consideration
 - If we have listed buildings can we request grants from the Council to help to preserve the fittings that are 'in keeping with the village'
 - Auditor report We need to work on further policies from the auditor's report and we need to claim VAT; these were the two main points from the exercise

- Parish Councillor recruitment There was a brief recap of the position, the duties and the time that it would take to fill the role before the motion was open for nominations. Chris Smith put himself forward, Sue Hartshorn seconded the motion and there was a unanimous acceptance of the post; paperwork will follow after the meeting.
