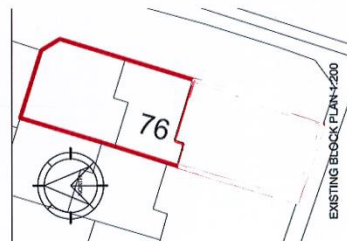
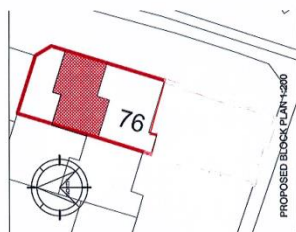

SE/18/03031: 76 Capelands, New Ash Green, DA3 8LQ – Single storey rear extension with rooflights. Cllr Mrs Connell PROPOSED that the Parish Council objects to this application as it would result in over intensification of the site due to its size and the significant reduction of the rear garden. It is important to note that the block plans for this proposal incorrectly reflect the area in front of number 76 as belonging to the property. All land in front of the houses in New Ash Green belongs to the New Ash Green Village Association and are maintained by each neighbourhood's Residents Society.
