1. Apologies for absence

There were no apologies for absence.

2. Public adjournment of the meeting

- The Village Hall Committee has declined the invitation to house a defibrillator on the outside of the Village Hall.
- The Village Hall shed roof is leaking.
- A Parishioner stated that the Parish Council was misusing public funds by asking to obtain
 illustrations of the proposed play area on Glebe Field. The same parishioner also stated that
 parents were being irresponsible drinking at the public house and allowing their children to go
 unsupervised to the Glebe Field. There was also a concern raised about the parking on both
 sides of the roadway outside of the public house.
