Windmill Close, Braybrooke Road, Great Oxendon Construction of dwelling (Plot 3)

Permission has been refused for the following reasons:-

- 1) The proposal for a new dwelling, in this isolated location in the open countryside and well outside the village confines, is an unsustainable form of development that is contrary to, and would undermine, the spatial strategy set out in the adopted development plan, specifically policies S1 and R1 of the West Northamptonshire Joint Core Strategy and policy RA6 of the Settlements and Countryside Part 2 Local Plan.
- 2) The siting and scale of the proposed dwelling itself, and its cumulative impact when considered alongside the adjacent new dwellings, would be detrimental to the rural character of the wider rural landscape and would fail to protect the special qualities of the Special Landscape Area, contrary to policy ENV2 of the Settlements and Countryside Part 2 Local Plan.
