TDC RENEGES OVER MANSTON AND NOW DANCES TO THE DEVELOPER'S TUNE

In 2015, TDC agreed and approved a new Local Plan, identifying sufficient housing developments to meet Government targets on the Island. This retained the Manston Airport site as an operational Airport.

They have now embarked on a Consultation Process for a revised Local Plan which, among other things, proposes the redesignation of Manston Airport as Mixed Use Settlement (i.e. 2,500 houses).

The justification for this U-turn (and complete reversal of the promises made at the last District Council elections) seems to be a consultant's report which suggests that Manston will never be financially viable. Whether the outcome of the Brexit vote was incorporated in this analysis is not clear, but the current government have frequently gone on record as saying that the UK is open for business - but both Heathrow and Gatwick are operating at near maximum capacity with passenger traffic, and air-freight capacity is at a premium until expansion at either (or both) airports is brought onstream - and where is there an airport with a surplus runway capacity, ready and waiting to meet the shortfall in the interim?

Furthermore, there are two potential operators who are anxious to run freight operations out of Manston - one of whom claims to have a pot of £200m to invest in the airport.


MISSED APPOINTMENTS

ACOL PARISH COUNCIL

Draft Minutes of the Acol Parish Council meeting held on Monday 16th January 2017 in the Village Hall, Acol, at 4.00pm.

Present: Cllrs Miss Bransfield (Chairman), D Hayfield, J Inchley and Mrs I Osborne

Also Present: Cllrs Crow-Brown (TDC) and Messrs. Mounter and Ratcliffe, KCC

(Parkway Development)

51. APOLOGIES FOR ABSENCE

Apologies were received from Cllrs. Hall (APC), Gregory and Grove (TDC), Latchford (KCC), Community Warden Gander and PCSO Raisbeck.

52. MINUTES

RESOLVED: That the minutes of the Meeting held on 28th November 2016, subject to an amendment to the minute numbering, be approved and signed by the Chairman.

53. DECLARATIONS OF INTEREST

The Chairman, Cllr. Hayfield and Mrs. Osborne disclosed non pecuniary interests in the tree surgery and Church Cottages in minute no. 57, Planning applications.

54. REPORT OF THE POLICE AND COMMUNITY WARDENS

No officers were in attendance to report but the Chairman read the report of PCSO Raisbeck in respect of matters relating to the Village. There were no calls to the police from Acol (01.12.2016-15.01.17), but there were several incidents of poaching and fly tipping bordering the village. Speed monitoring indicated that the majority of road users are abiding by the speed limit.

The Clerk to ask Craig if he knows the whereabouts of the hand-held speed monitoring equipment.

55. REPORT FROM KCC ON THE PARKWAY STATION PROPOSALS AND THE CONSULTATIVE PROCESS TO BE ADOPTED.

Council received a presentation by Messrs. David Mounter, Project Manager, and Joe Ratcliffe, Transport Strategy Manager. They outlined the procedures for the forthcoming consultation period, taking place between 25th January and 19th March. Members noted that the Acol Village Hall had been booked for 20th February 2017 between 2 and 8 p.m. for a public viewing.

The Chairman asked what road improvements were planned and highlighted the unacceptable volumes of traffic through Acol, which will increase with the Parkway Station. A new road is urgently required, by way of extending Columbus Avenue.

56. LITTER

Villager Richard Steel set out his concerns at the amount of litter within the village and outlined his intention to form a litter-picking group to tidy up the village.

RESOLVED: That (A) the Clerk will enquire at Minster and Birchington to ascertain their procedures, (B) the initiative be publicised in the Village Voice, with a view to (C) setting up a litter-collection group and (D) the Clerk to purchase appropriate equipment required.

57. PLANNING APPLICATIONS

The Chairman reported that approval had been given for tree surgery needed in the front garden of Orchard Cottage.

Cllr Mrs Osborne expressed concern that the Parish Council had not been advised of the new planning proposals in respect of 2 Church Cottages. Adjacent residents had submitted objections, but other villagers and the Parish Council were unable to respond. The Chairman has contacted TDC's Planning Department to point out their omission, with no response, and the Clerk will seek an explanation from TDC.

58. CHAIRMAN'S REPORT

The Chairman reported upon:

Volunteers

Thanks are due to Bob Lawrence and Norman Chidwick for repairing the fence on the recreation field and Bob's work on the fence around the commemorative oak tree. The tree has grown so big that a fence is no longer needed. Bob is making a post to display the information plaque.

More thanks to Bob, Norman and Cllr Hayfield for taking down the Christmas tree and decorations, as well as everyone's efforts for putting them up in time for the first Christmas party.

Website

Apologies for not posting the Agenda on the website. KCC have changed the website again and it is very poor quality and difficult to use. An alternative provider or facility will be investigated.

BT Kiosk

TDC are instigating its removal and they have been sent all previous correspondence and documents confirming its retention. They have confirmed receipt, but not yet responded.

Southern Water

Following the attendance of S Water personnel at the meeting arranged by Sir Roger Gale MP on 5th December, no response was received, despite promises to do so. Consequently, an official complaint has been lodged with the Consumer Council for Water, following advice from Sir Roger. An acknowledgement has been received and their response awaited.

Kent Highways

There is another list of faults in our road surfaces that will be sent to Paul Valek.

Lord-Lieutenant of Kent's Civic Service

The Parish Council received invitation to the annual service at Rochester Cathedral on 14th March, but no Councillor was able to attend. The Chairman will respond accordingly.

59. RECREATION GROUND

Cllr. Hayfield reported that the children's play area was being refurbished.

60. CCTV CAMERAS WITHIN THE VILLAGE

The cameras had recorded 2 traffic related incidents within the Village.

61. CLERK'S REPORT

The Clerk had no further matter to report upon.

62. FINANCIAL MATTERS/BUDGET/PRECEPT

The Clerk reported upon draft budget proposals for the year 2017/18. Members were also advised of the predicted balances at 1 April 2017.

RESOLVED: That (A) That the budget as amended and in the sum of £4,380.00 (as attached to the minutes) be approved and submitted to the District Council for approval; and

(B) the anticipated bank balance at 1 April 2017 in the sum of £8,222.15 be noted.

63. REPORT OF COUNCILLOR CROW-BROWN (TDC)

Cllr Crow-Brown: (i) New Homes Bonus – Government had indicated that there would be a cut to the new house bonus payments in years 4 & 5 of the scheme, (ii) TDC had appointed a new Cleansing Manager who was introducing new measures to combat illegal parking and fly tipping. To date 17,000 enforcement tickets had been issued; and (iii) Armed Forces initiative – the Chairman of TDC would be attending an event in Chatham and it was expected that the armed forces reserves would be moving to Manston.

64. MATTERS FOR REPORT BY MEMBERS

Cllr. Hayfield - no further matter for report.

Cllr. Inchley – no further matter for report.

Cllr. Mrs. Osborne – investigations were being carried out to refurbish the Village Hall kitchen.

65. DATES FOR FUTURE MEETINGS

The next meeting would be held at 2pm on Tuesday 28th February 2017, followed by a further meeting at 2pm on Monday 3rd April, when a date will be fixed for the Annual Parish Assembly and Parish Council AGM in May.

KCC CONSULTATION - PARKWAY STATION

The only thing worse than having one Council Consultation is having two, both from KCC, at the same time!

The Proposed Revisions to the Local Plan as they relate to Manston Airport will generate much opposition from well established organisations and lobby groups.

The Parkway Station, however, while it may benefit Thanet as a whole, will seriously impact upon Acol and the lives of every resident. Such a threat needs everyone to respond individually, to express their objection to the proposed access routes from the Northern coastal strip (Margate, Westgate, Birchington) to Cliffesend. The expectation that such traffic would use the A28 to reach the St Nicholas roundabout and then use the A299 to get to the proposed Parkway site when a perfectly viable "rat run" through Acol exists surely needs to be challenged vigorously? The volume of traffic through our village has already reached unacceptable levels and a new station at Cliffsend will just bring more misery to our lives.

KCC needs to be reminded that road access needs improving, by way of EXTENDING COLUMBUS AVENUE.
