5. **Planning**

Mr & Mrs Paice – 3 Low Road – Demolition of existing conservatory and erection of single storey extension to rear – no observations.

Mr Andrew Sparrow – Ancient Unicorn – Conversion of managers flat to additional letting accommodation and refurbishment of public house including the replacement of windows and screens – no observations.

Clerk to write to planning officer Jill Conroy and send a copy to the Unicorn saying that Bowes Parish Council are pleased it is being refurbished sympathetically and re-opened.

7. **Cemetery maintenance**  
Request for additional inscription for Mrs L Clowes – Approved  
Sods have taken well, and a small amount of turfing remains to be done.
8. **Travellers**  
The travellers have removed the clasp and the lock off the gate again, and their horses were grazing. We had two toilets delivered, not tied together, and they fell over again. Horses were put into Chris Tunstalls field twice. On the whole, it has been relatively trouble free again.
9. **Allotments**  
The Tenancy agreement was approved, new tenancy agreements to go out in November with the payment request.  
Andrew Lacey paid £3.00 in cash for Mr M Branthwaites plot for next years rent.  
Clerk provided a breakdown of income and costs for West Clint Field, which showed a profit on West Clint Field of £1255.00 from 2007 to date and a loss on the allotments of £1155.36 for the same period. The rent from Youngs is increasing, and due to allotments taking up part of the grazing field the rent coming in has reduced. Costs will be monitored, but allotment rents may have to be increased.  
Denise Marmont has asked to go back onto the waiting list as she would like a larger plot.  
Mr Russell wrote to the clerk asking for a plot to share with Mr Whittle (Dotheboys Hall).  
A complaint has been received regarding Mr Fairburn's plot. Clerk to write to him – you have 28 days to get your plot back in order, otherwise you will be asked to relinquish it.
10. **Play Park**  
Graham Irvine recently reported that the Leslie Longstaff memorial seat was found in pieces before the last grass cut. Inspection revealed that though some vandalism may have occurred the timber was rotten, especially around the joints. The debris has been removed as a safety measure. Before considering replacing the bench councillors will ask parishioners if they would like to put up a memorial seat.

Cllr White has put in a grant for £1012.00 for 4 stiles.
