A parishioner said he has a water meter and was charged for high usage showing on the meter but is now back to normal usage. He has had to pay the large sum for water they did not use. The clerk said she had had the same problem last year. She insisted she had not used the high reading on the meter and insisted South East Water came out to check. A leak was found and the water pipe was replaced from the road to her house with no charge to her. The chairman advised the parishioner contacts the water company again and if not resolved to write to OFWAT and our M.P

A parishioner said the Oak trees opposite Woodmans Oak Cottages during the last high winds branches came off the trees with one branch falling across the road onto parked car causing damage. As it not clear if the trees are on private land or the grass verge Councillors Field advised them to contact East Sussex Highways asking them to visit and advise further. She will forward the name of the person to contact.

Several parishioners said they are having problems with the very high Lalandi hedge in a neighboring property. The block out the light causing them to have the lights on during the day. They have spoken to the owner, but no action has been taken to lower them. Councillor Field advised they contact Richard Parker at Rother asking him to visit and explain what can be done.
