(2020 – 020) Present were Cllr Robert Weatherhead (Vice Chairman), Cllr Ben Robinson, Cllr Jan Lawson, Cllr Patricia Harling, Cllr. Sheila Miller and.

(2020 – 021) Also present were David Taylor, Clerk. There were no members of the public.

(2020 – 022) Apologies were received and accepted from Cllr Brian Thackray and Cllr Margaret Atkinson.

(2020 – 023) No **Declarations of Interest were** received and no **dispensations** were required.
